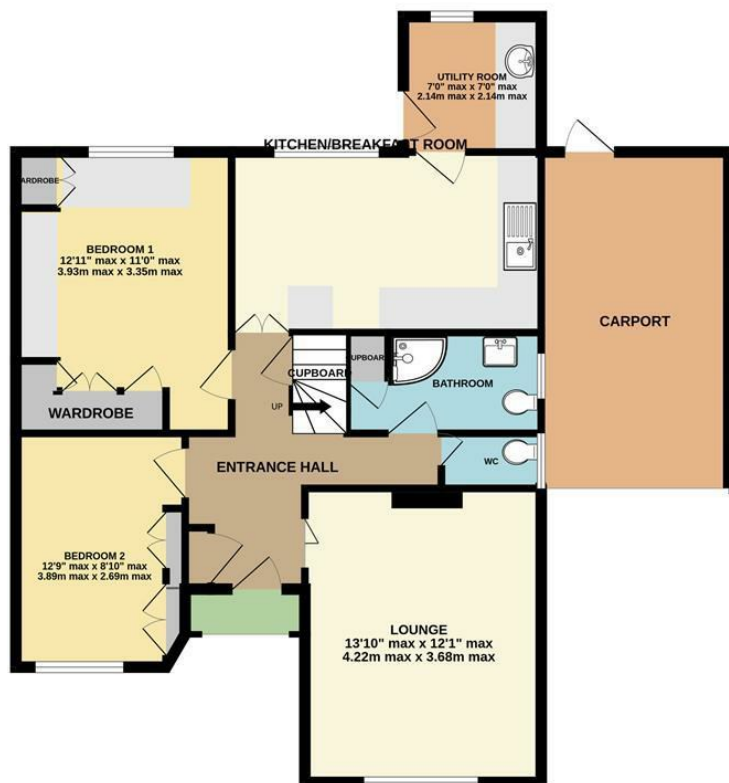

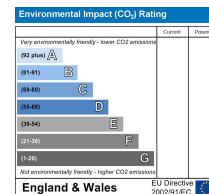
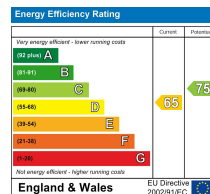
1ST FLOOR
