The property comprises a porch which leads into an entrance hallway which allows access to an open plan lounge/dining and a separate well appointed kitchen. Outside to the front is off-road parking and benefits from having a garage for additional parking space and storage area. To the rear is a well presented rear garden.

Location And Area

Set back from the roadside behind ample off road parking with access to the main accommodation and garage.

Radiator, storage cupboard, ceiling light point, stairs to first floor, doors to lounge/ dining room and kitchen.

Lounge/ Dining Room

Double glazed windows to front and rear, two ceiling light points, two vertical radiators, gas fire place, two wall lights.

Kitchen

13' 5" x 7' (4.09m x 2.13m)

Matching wall and base units with stainless steel sink and drainer with mixer tap, plumbing point for washing machine, space for fridge freezer, ceiling spotlights, tile walls, radiator, extractor hood, double glazed window to rear, doors to hallway and lobby.

Double glazed window to side, door to kitchen and garden.

Doors to various rooms.

Bedroom One

13' 9" max x 11' 4" into wardrobe (4.19m max x 3.45m into wardrobe)

Double glazed window to front, radiator, fitted wardrobe, ceiling light point.

Bedroom Two

4' 9" into wardrobe x 10' 10" max (1.45m into wardrobe x 3.30m max)

Double glazed window to rear, radiator, fitted wardrobe, ceiling light point.

Bedroom Three

7' 9" x 7' 8" (2.36m x 2.34m)

Double glazed window to front, radiator, ceiling light point.

Bathroom

Panelled bath with shower attachment, low flush wc, separate shower cubicle, heated towel rail, vanity wash hand basin, ceiling light point, partly tiled walls, double glazed window to rear.

Outside Rear

Patio area with lawn, side path, outside tap point, timber shed and side gate.

Garage

18' 7" x 7' 6" (5.66m x 2.29m)

Up and over garage door.

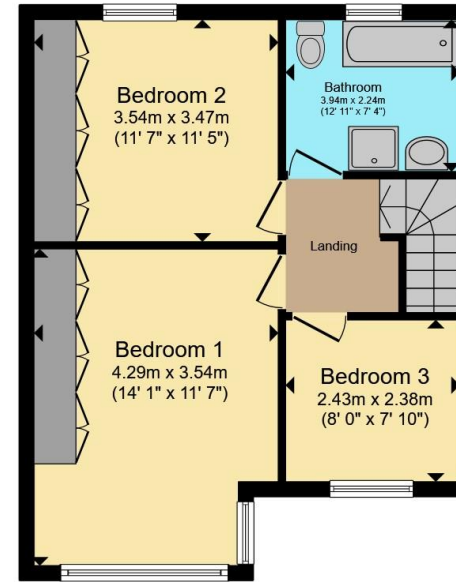








Ground Floor
