A well presented three bedroomed semi detached family home located in a popular residential location. The property benefits from gas fired central heating, Upvc double glazing and solar panels. The accommodation includes a reception hall, spacious living room with double doors leading to the open plan kitchen/dining room. The kitchen area is fitted with wall and base units together with integrated oven, hob, microwave and dishwasher. The dining area has a breakfast bar area and French doors opening to the rear garden and patio. To the first floor there are two double bedrooms, one with fitted wardrobes and a single third bedroom. The bathroom is fitted with a modern suite with vanity unit and shower over the bath. The loft is boarded and accessed via a timber ladder. Externally there is a front garden, driveway providing off street parking and access to the garage with remote door. The rear garden enjoys a south facing aspect with patio, lawn and garden store. There is no onward chain.

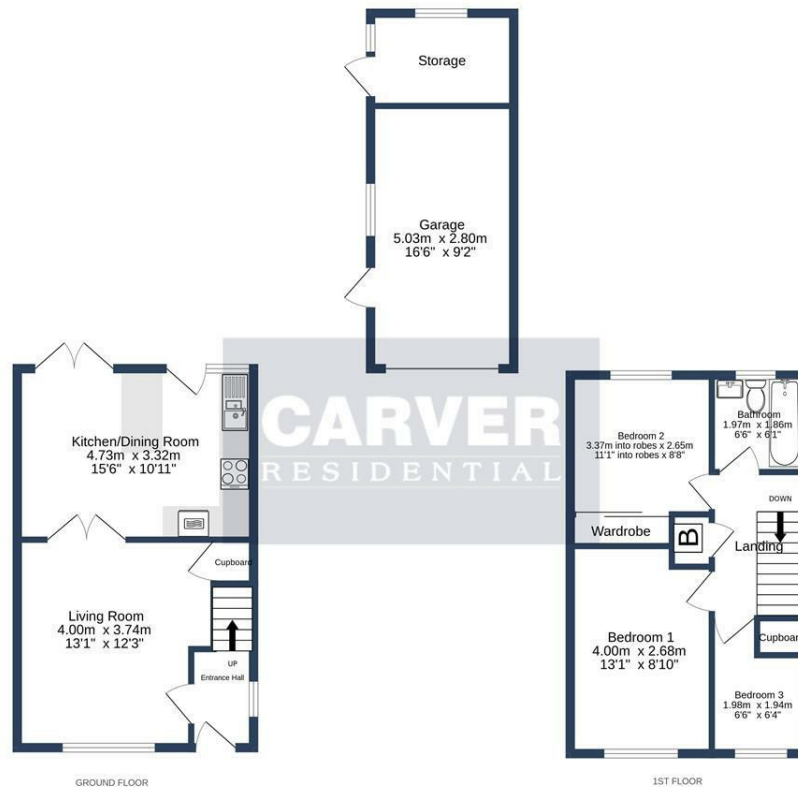
