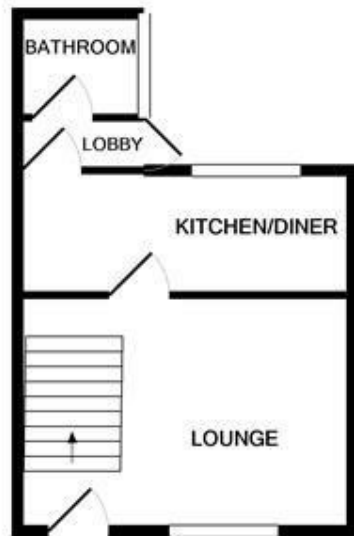
Holding Deposit And Deposit - All of our rental properties require a Holding Deposit equivalent to 1 week's rent. The Tenant is entitled for this Holding

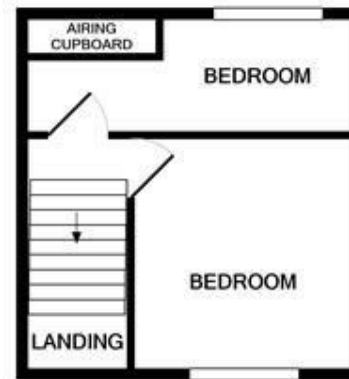
You will lose your Holding Deposit if any of the following occurs:
