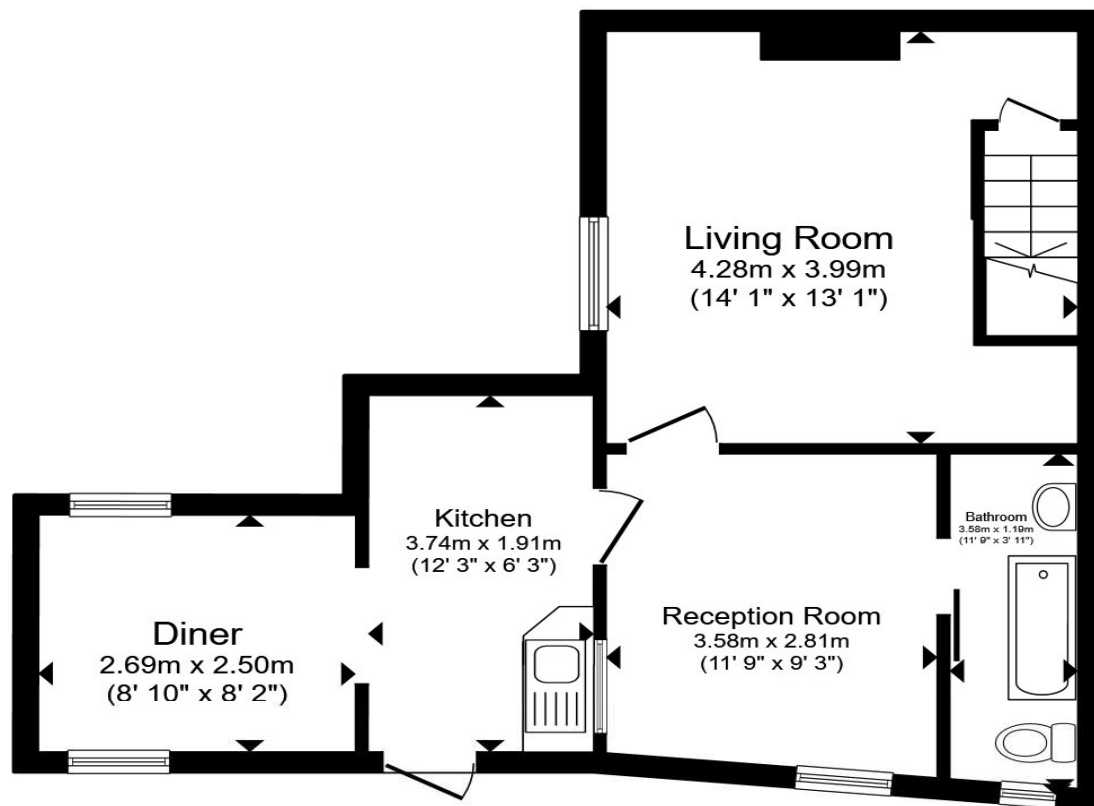
To the outside of the property there are wrap around gardens, with a driveway providing parking for multiple vehicles.

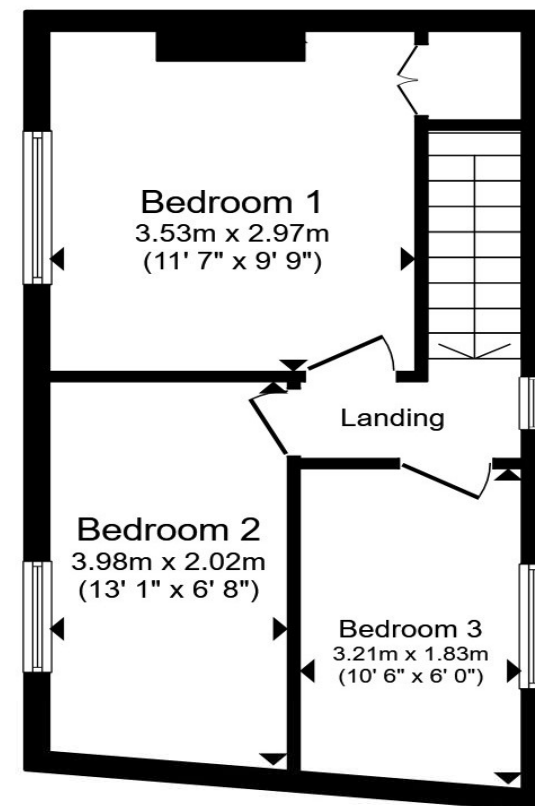
