### **Cloakroom/W.C.**

Fitted with a suite comprising low level w.c, pedestal wash hand basin with mixer tap over, radiator, wall mounted boiler, part tiled, extractor and window to front.

### **Kitchen**

With radiator, restricted head height and window to rear aspect.

Fitted with a suite comprising shower enclosure, low level w.c, pedestal wash hand basin with mixer tap over, towel ladder radiator, part tiled, restricted head height, shaver point and extractor.

To the front of the property there is a lawned garden with a pathway leading to the front door. Allocated parking is situated in front of the property.
