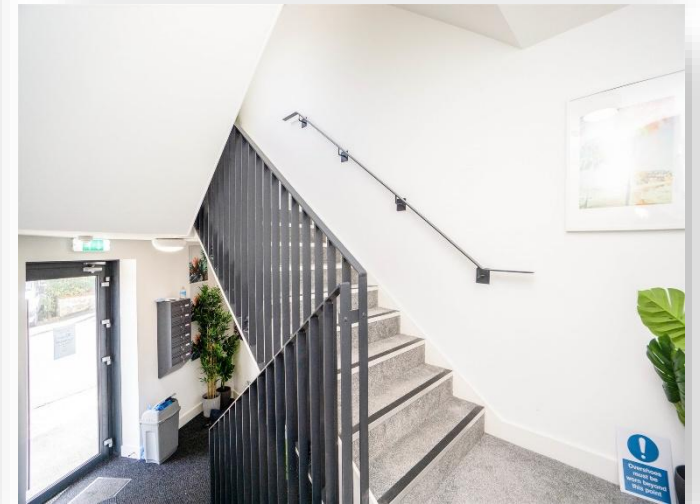

Early viewing is highly recommended to fully appreciate the accommodation on offer.

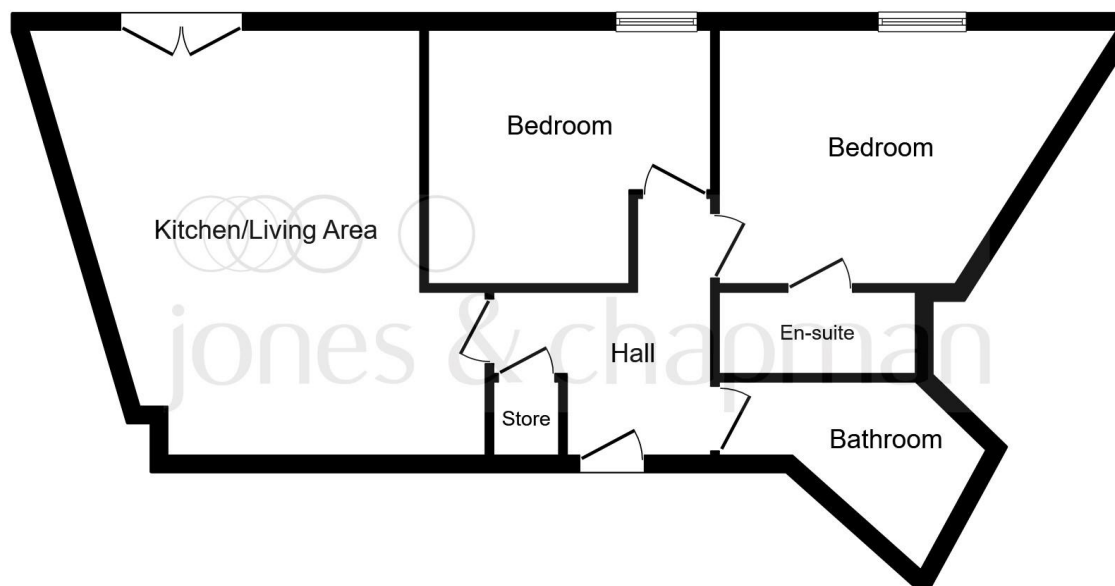
