THE PROPERTY

Clare Cottage is a delightful 18th Century thatched Grade II cob cottage, forming part of the picturesque gentle slope of 'The Street'.

Upon entering the property there is a communal front entrance porch with door to the sitting room which has original stone flooring, a large inglenook fireplace, villager woodburning stove and bread oven. There is a dining room with stairs to the first floor and good size kitchen/breakfast room with quarry tiled floor.

The master bedroom is a double with leaded light French windows overlooking the patio area with en-suite shower room. A second flight of stairs to the front of the property leads to two further bedrooms and a family bathroom.

The property has an open plan front garden laid to lawn and parking for two vehicles. Side access leads to gravelled area directly outside the kitchen and steps to a patio area which leads from the main bedroom. Further steps to a sloped garden with beautiful views at the top over the village.

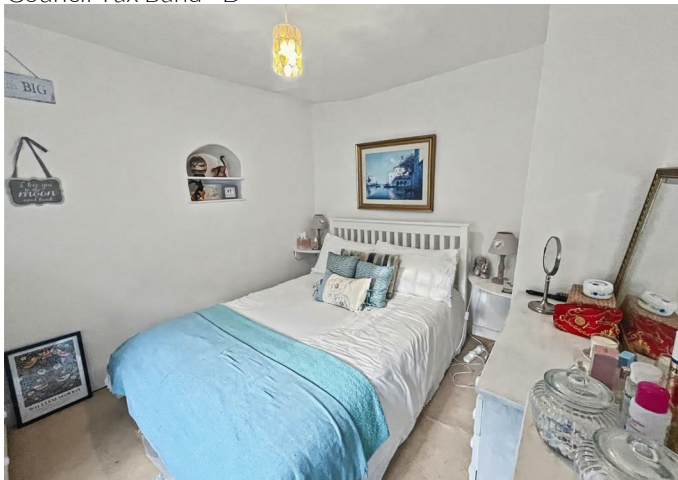

The nearby market town of Blandford Forum is approximately 7 miles and the County town of Dorchester, with mainline station is approximately 10 miles and both offer commercial, shopping and sporting facilities.
