It is a condition of the purchase that residents are over the age of 60 years.





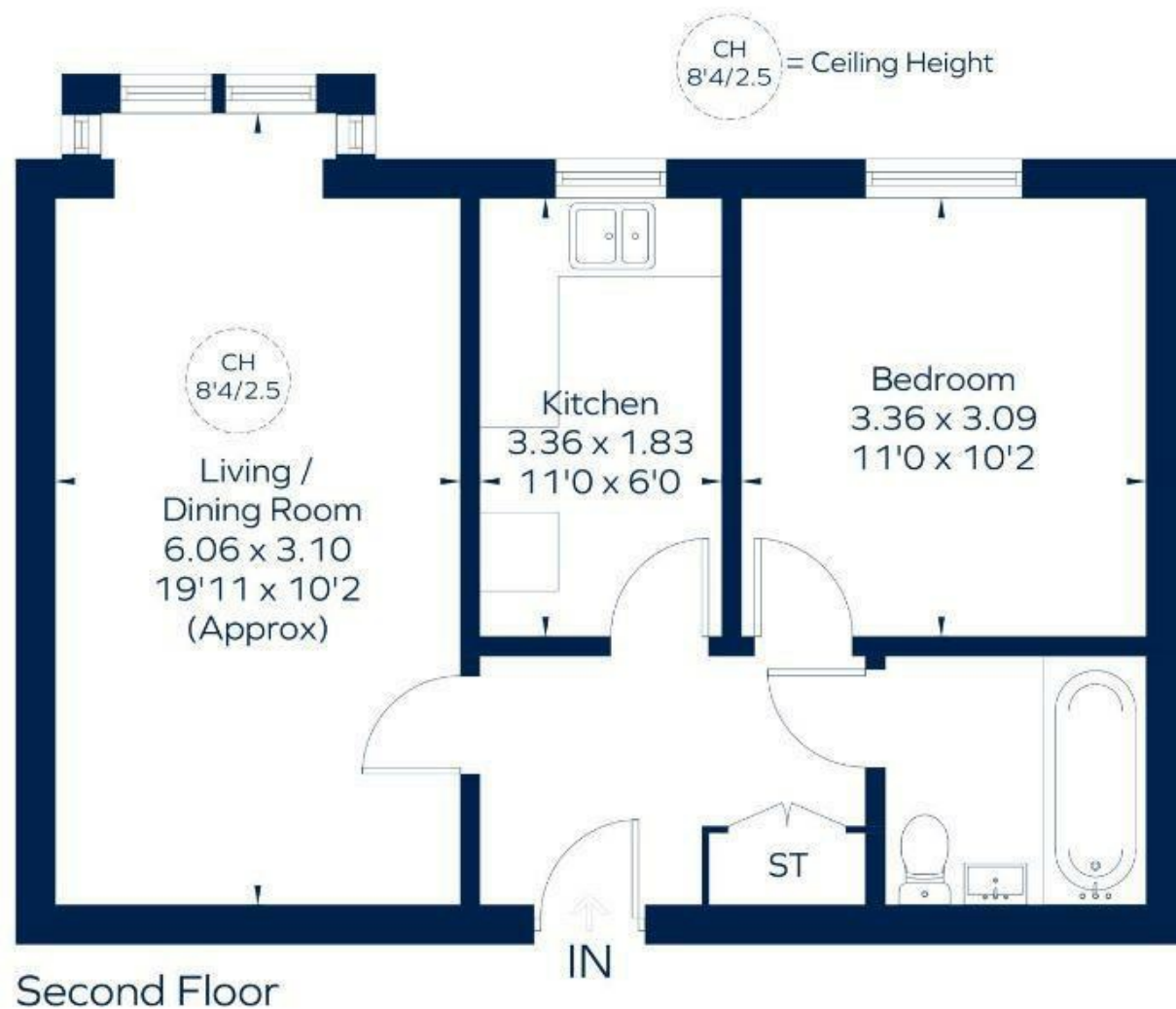
