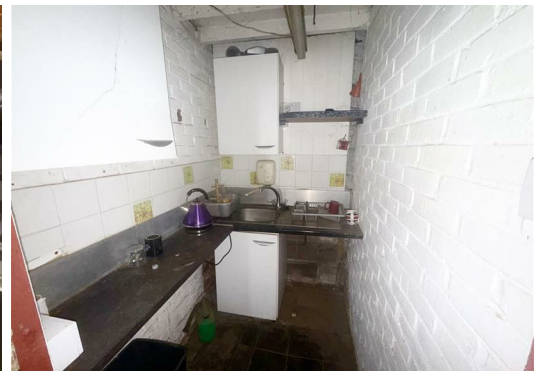


First Floor
