

13 Monument Close is a two bedroom semi detached bungalow situated in a popular cul-de-sac on the south side of Wellington within walking distance of the town centre. Offered to the market with vacant possession and NO ONWARD CHAIN.

The accommodation comprises in brief; front door opens into the entrance hall with a large built-in storage cupboard and doors to the principal rooms. The kitchen is fully fitted with a comprehensive range of wall and base units with an integrated oven and hob, fridge and freezer alongside space for a washing machine and dishwasher. The sitting/dining room is a generous size with ample space for all everyday furnishings and a feature fireplace.

An internal hallway provides access to the loft space which is boarded with a drop down ladder and which contains the combination gas boiler which is approximately 3 years old. The master bedroom is fitted with a range of wardrobes alongside the second bedroom and the bathroom which comprises a white suite with a shower over the bath.

To the rear of the property, there is a conservatory accessed from the second bedroom with a doorway into the garage which has been converted and now provides an additional space which would make perfect use as a second reception room or home office with the adjoining shower room.

Externally, the property is set back from the road with a garden to the front elevation alongside a driveway which slopes down from the road to provide parking for up to 5 vehicles. The main garden lies to the rear and is predominantly laid to lawn, enjoying a good degree of privacy with mature borders and a patio.
