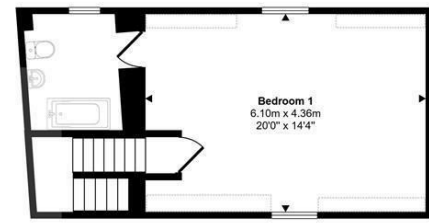
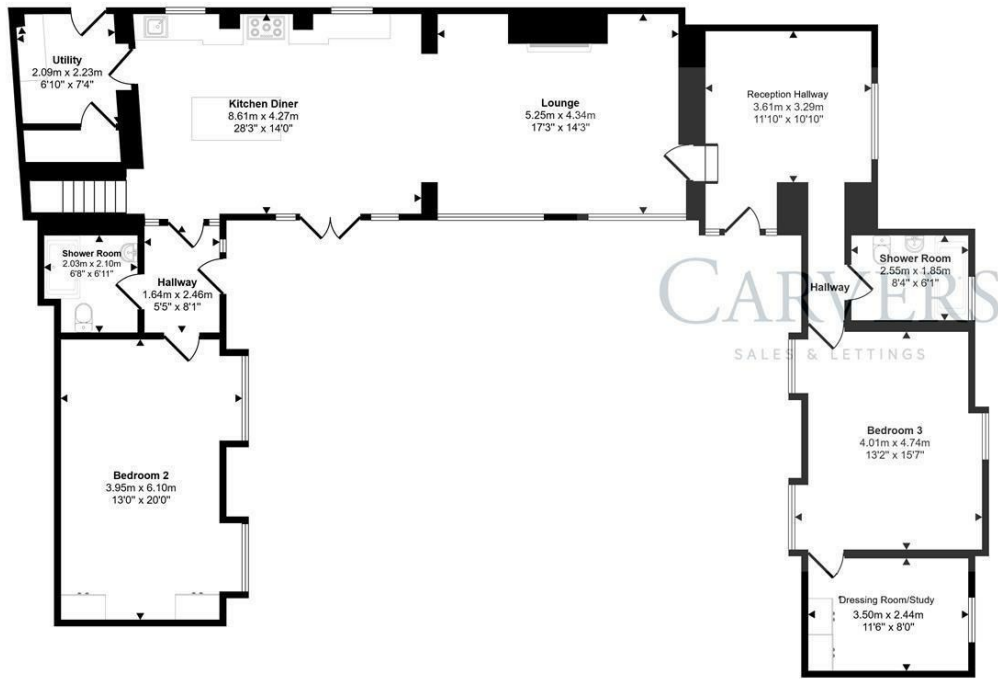
**Buyers Identification Checks**

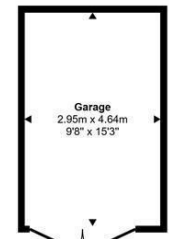
