# The Property

---

A truly remarkable four-bedroom, three-bathroom link-detached house located in the heart of Hampstead Village. Originally constructed in 1883 as a mission hall for St Stephen's Church and later converted into an artist's studio, this unique property has recently been tastefully and meticulously refurbished by the current owners. Features include a smart lighting control system, air-conditioning in the South facing bedrooms, integrated Sonos audio, mobile-controlled underfloor heating, high-quality bespoke joinery throughout, and a range of building upgrades.

Offering approximately 2,767 sq ft of accommodation and gated off-street parking, the house beautifully blends impressive architectural features with contemporary fittings. The breathtaking reception room features a wonderful vaulted ceiling with exposed beams and a mezzanine living area, accessed via a charming spiral iron staircase.

The fully integrated kitchen and separate utility room are located on the ground floor, with the utility room providing access to one of two patios. To the west side of the house, a further patio can be accessed via the study, which also connects to an en-suite bathroom serving a bedroom. Two additional bedrooms are accessed at the back of the ground floor.

The impressive principal bedroom suite occupies the first floor and benefits from fitted storage, an en-suite bathroom, and a private terrace. A dressing room or flexible additional space leads to a further terrace, completing this exceptional home.

Denning Road is set in the centre of Hampstead and is ideally located for the Heath, as well as the cafés, boutiques, and restaurants of





