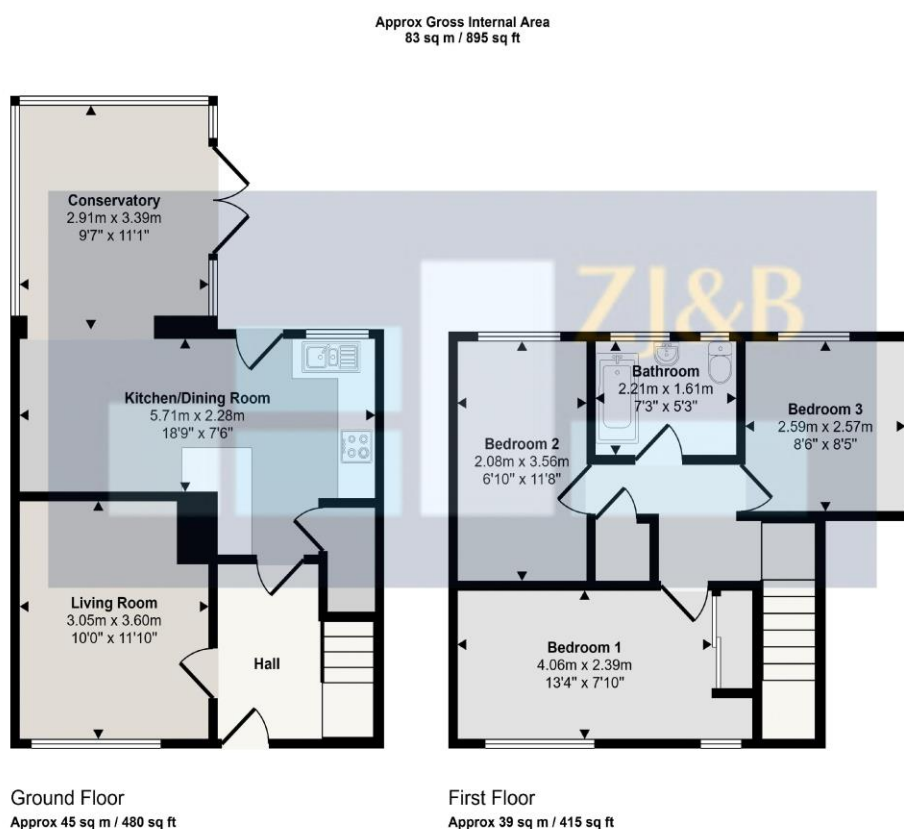

Located in the popular Springfield area of Shrewsbury, close to the College and Business Parks, enjoying gas central heating and double glazing. Approached through a double-glazed entrance door into the entrance hall with the living room to the left, overlooking the front aspect. To the rear of the hall, a door leads into the spacious kitchen/dining room, which has tiled flooring and is fitted with an excellent range of units, including an integrated electric oven and 4-ring gas hob with filter hood above. From the dining room, there is a wide opening into the conservatory, and enjoys views over the garden. The staircase from the hall leads to the first-floor landing and three good-sized bedrooms. The main bedroom has two windows to the front and a built-in wardrobe. The second bedroom overlooks the rear garden, and the third bedroom also faces the rear and enjoys extra space. The property shares a flying freehold with the adjoining property over the passageway. The bathroom completes the accommodation and is fitted with a 3-piece suite. The large rear garden is enclosed by timber fencing and includes patios, extensive lawns and a useful timber shed.

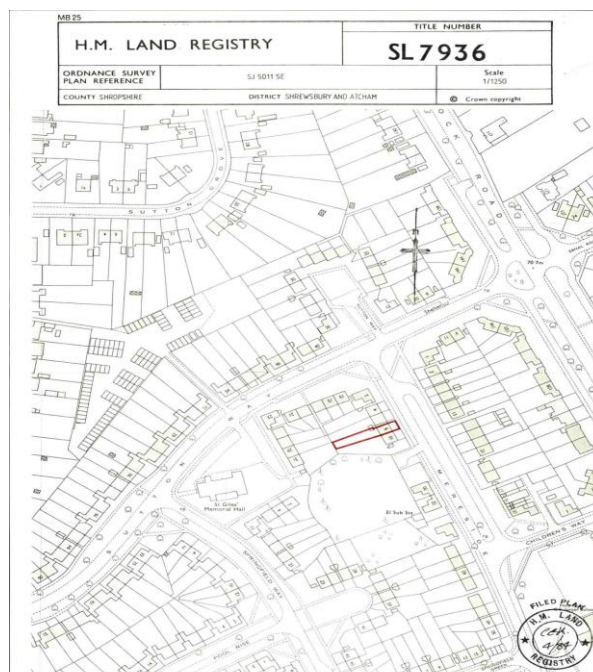
