Window to front. Fitted carpet.

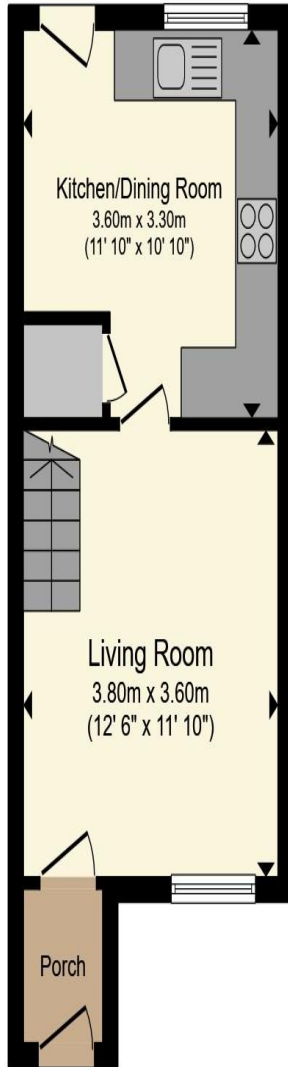
Bedroom Two -

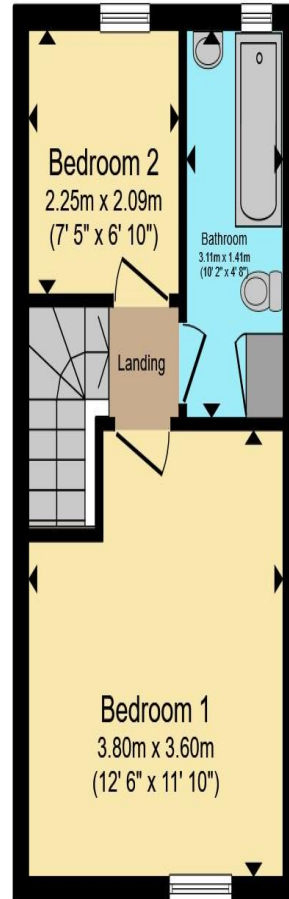
Outside -
