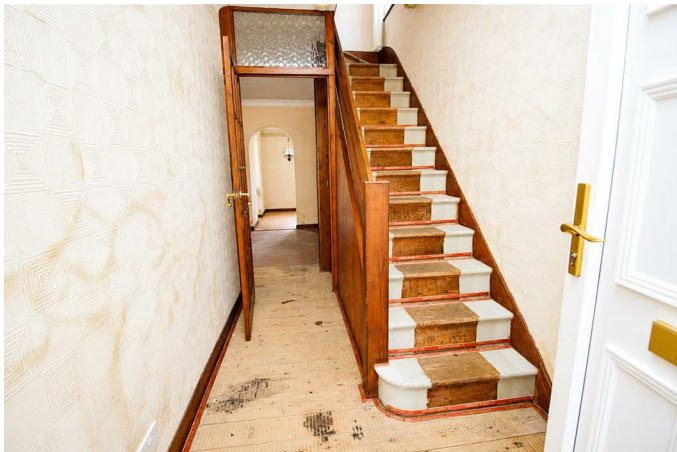

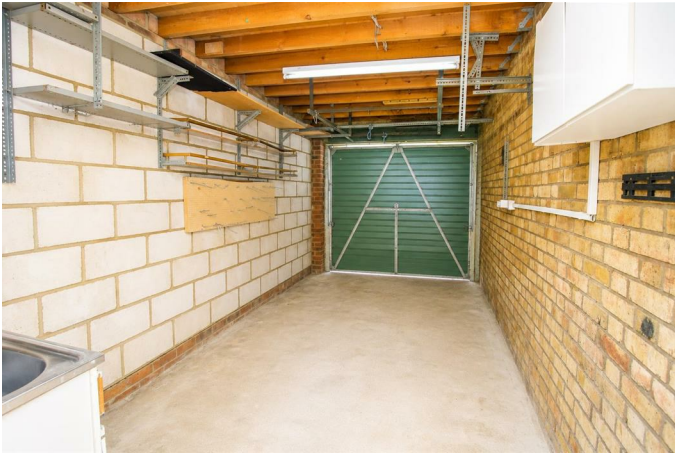

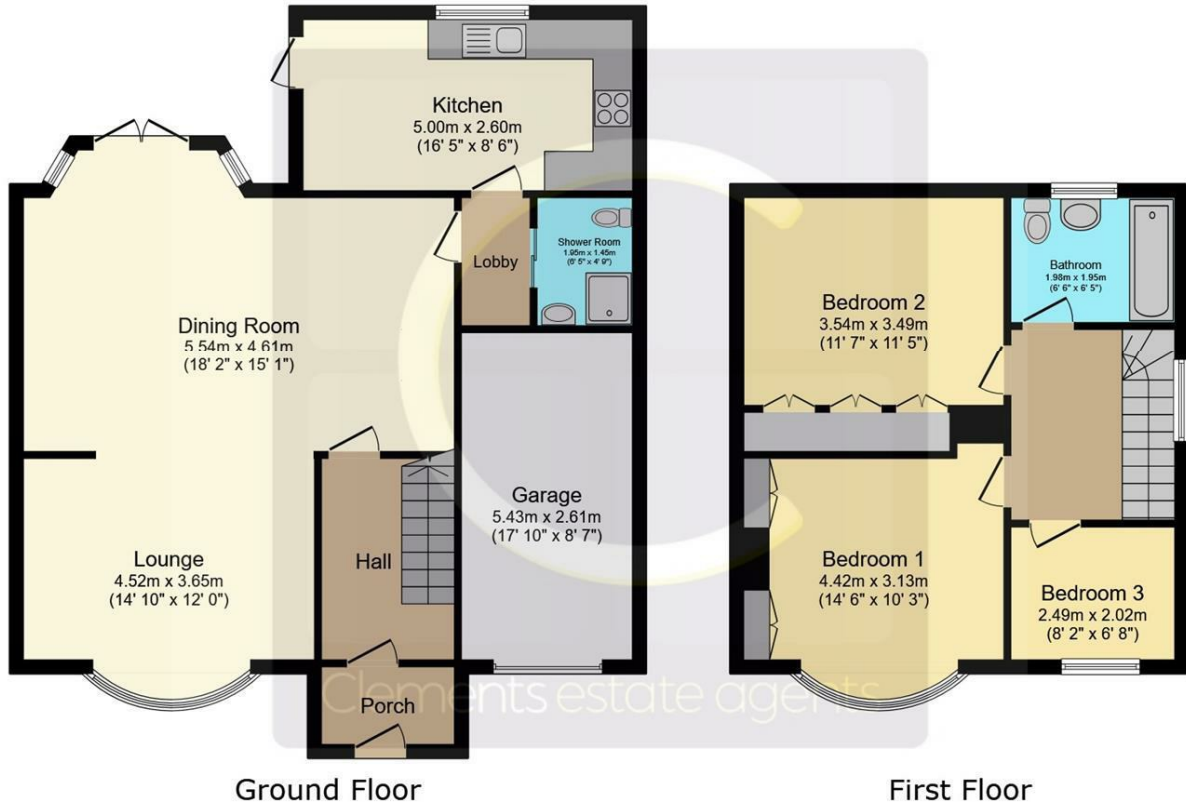

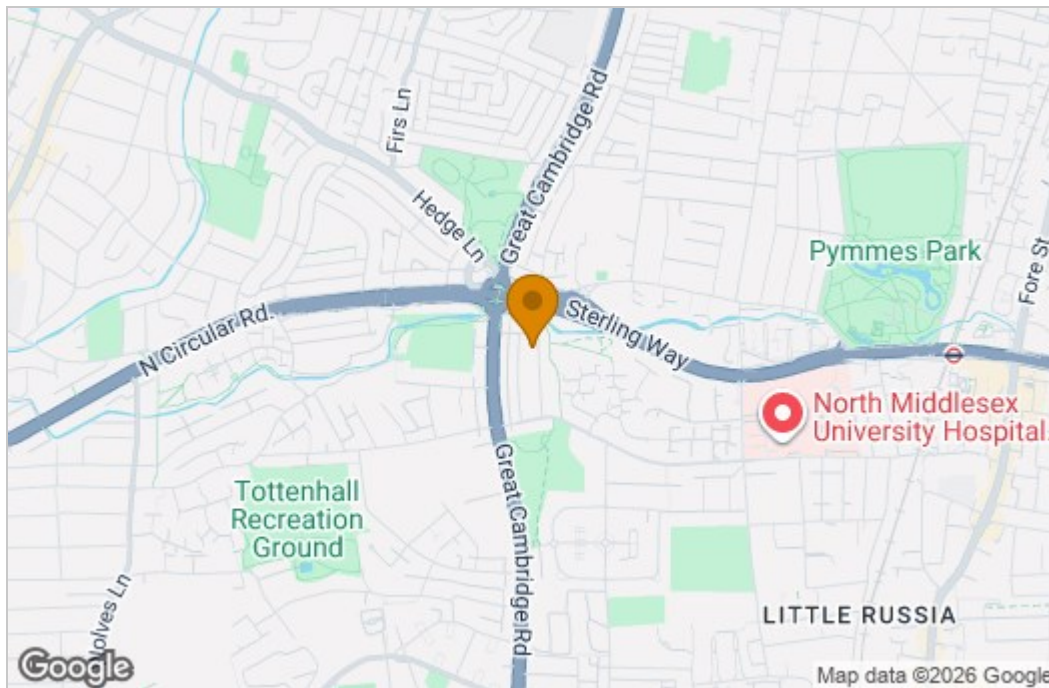

Floor Plan

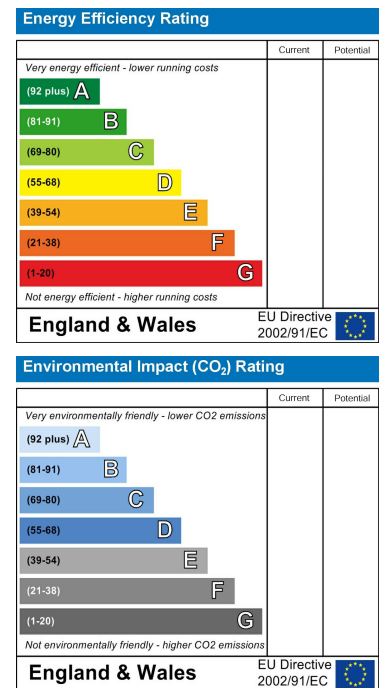
