Accessed via a pedestrian gate and pathway leading to the side entrance, the accommodation opens into a welcoming entrance hall. The well-appointed kitchen offers an excellent range of fitted cupboards and work surfaces, complete with an integrated fridge freezer and a convenient breakfast bar seating area.

To the front of the property, the bright and spacious living room enjoys a large bay window overlooking the front garden, creating a light and inviting space to relax. The principal bedroom is generously sized and benefits from fitted wardrobes, while the second bedroom, currently utilised as a dining room, features sliding patio doors leading into the conservatory.

The conservatory provides an additional reception space with pleasant views over the rear garden and direct access onto the generous paved patio, making it the perfect place to relax or entertain. Completing the accommodation is a well-presented family bathroom.

Externally, the property occupies an impressive corner plot with beautifully maintained, low-maintenance gardens incorporating lawned areas, a substantial paved patio and attractive flower borders. A

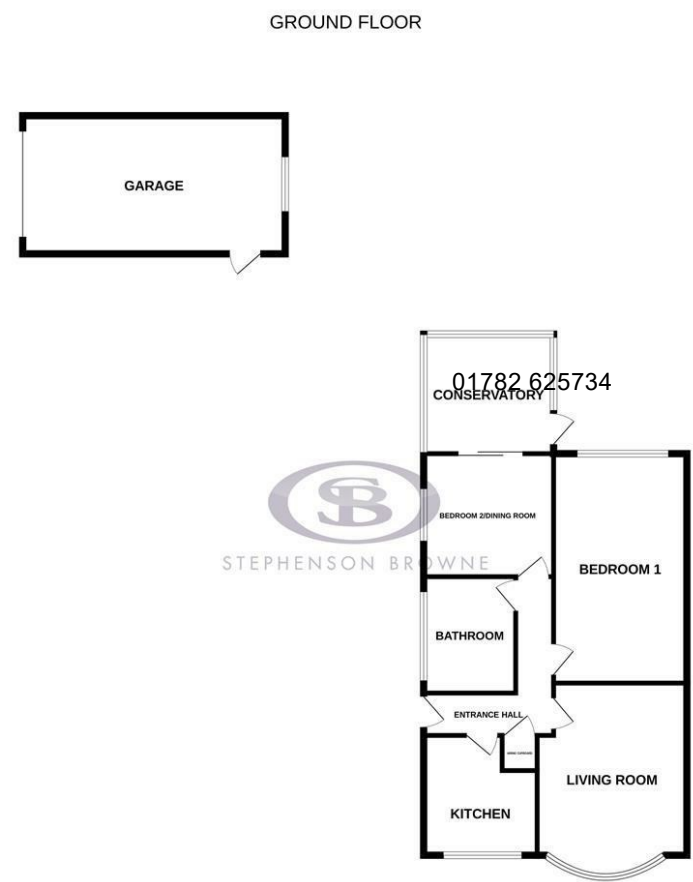

Floorplans

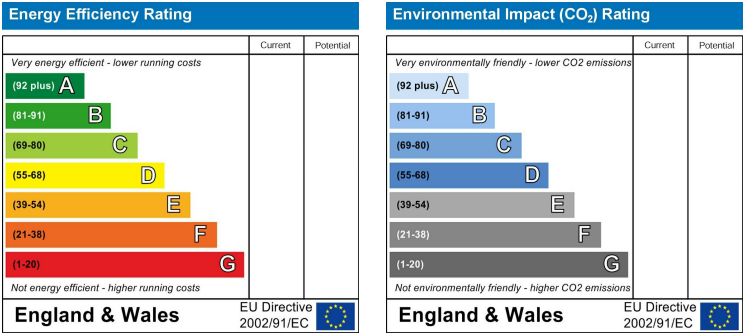
