Upstairs, there are four well sized bedrooms, two of which benefit from built in wardrobes. A family

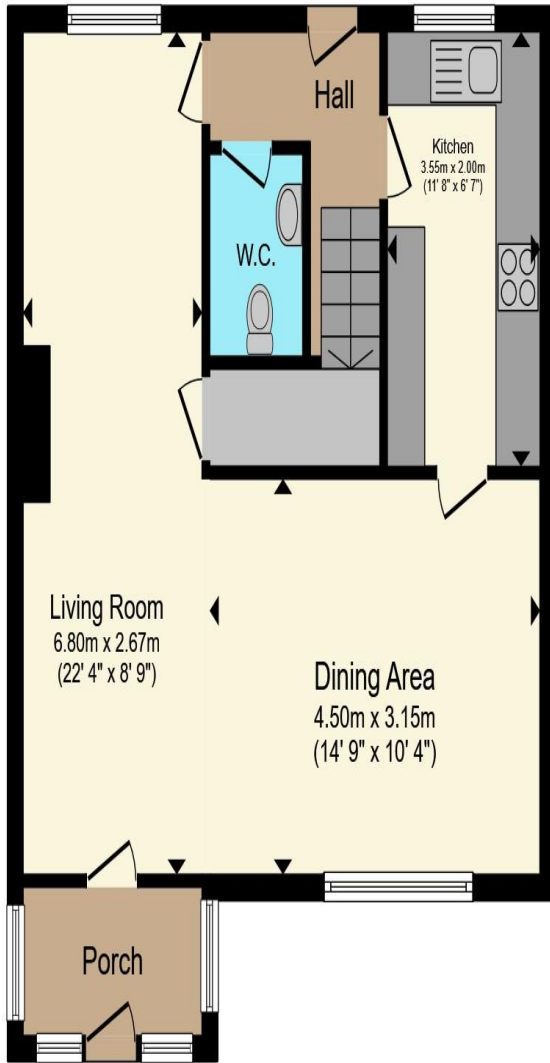

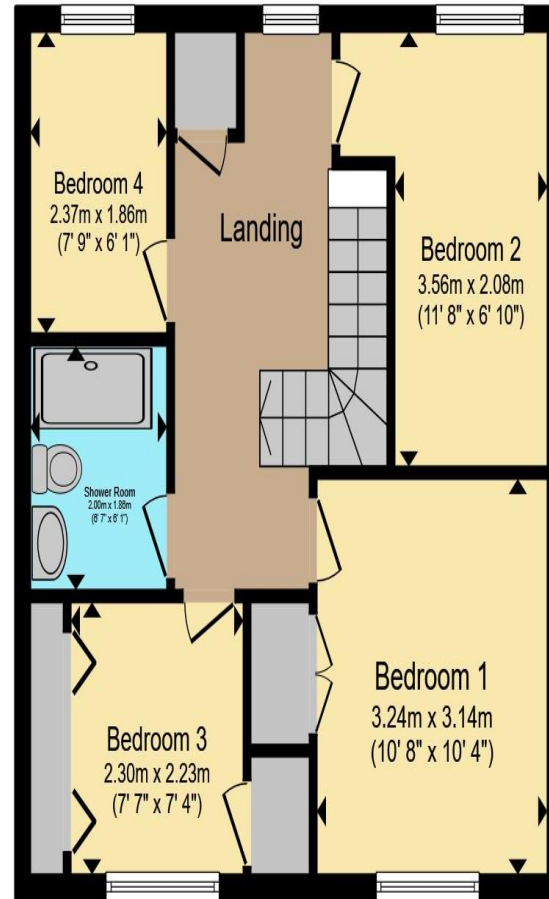
This home combines character, potential, and an exceptional village setting-perfect for buyers looking to put their own stamp on a property in a prime location.
