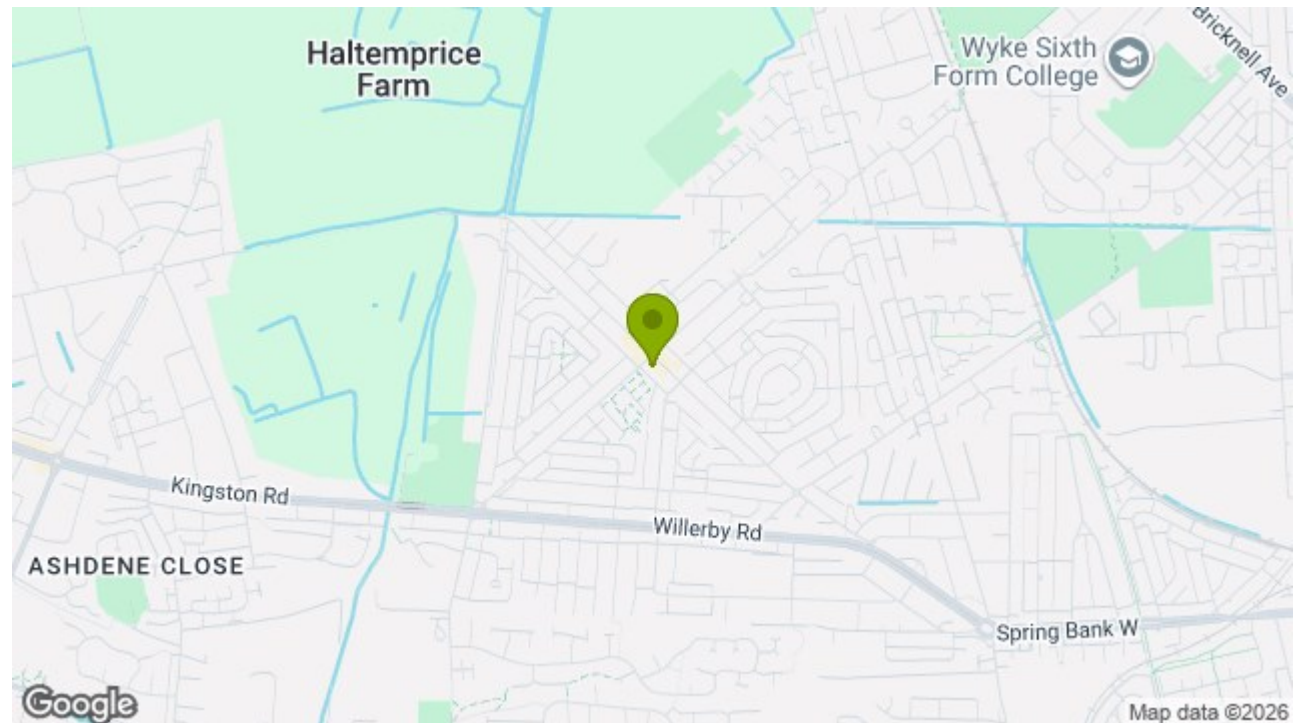

ENTRANCE HALL

Providing access to the accommodation.
