



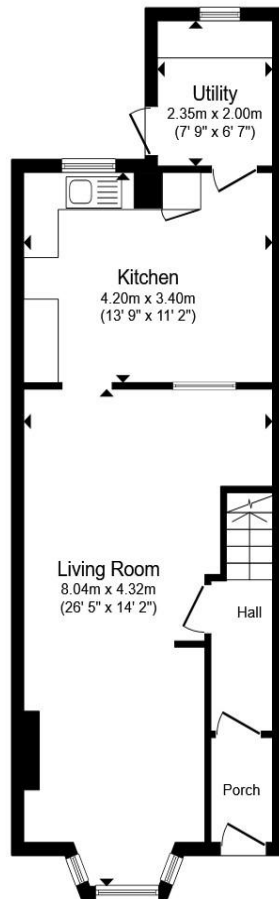

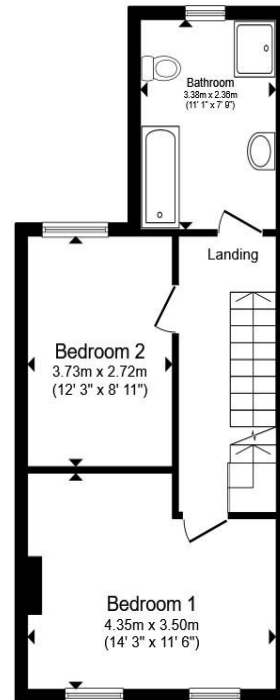

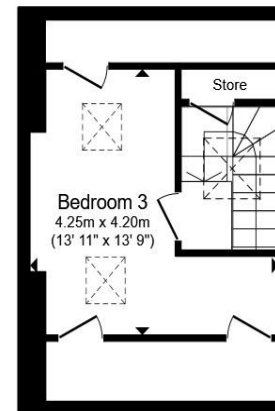




Ground Floor
