DESCRIPTION

A single parcel of land extending to 21.95 acres (8.88 ha) outlined red on the attached plan. The land is strategically placed between the villages of Alconbury Weston and Alconbury. The land has excellent access directly onto North Road. Title Number CB208614.

The field is Grade 3 as categorised by the Agricultural Land Classification of England and Wales. The soil type is from the Evesham 3 series being described as "Slowly permeable calcareous clayey, and fine loamy over clayey soils" by the Soil Survey of England and Wales.

LOCATION

The land comprises a single parcel of arable land in the parish of Alconbury Weston fronting North Road.

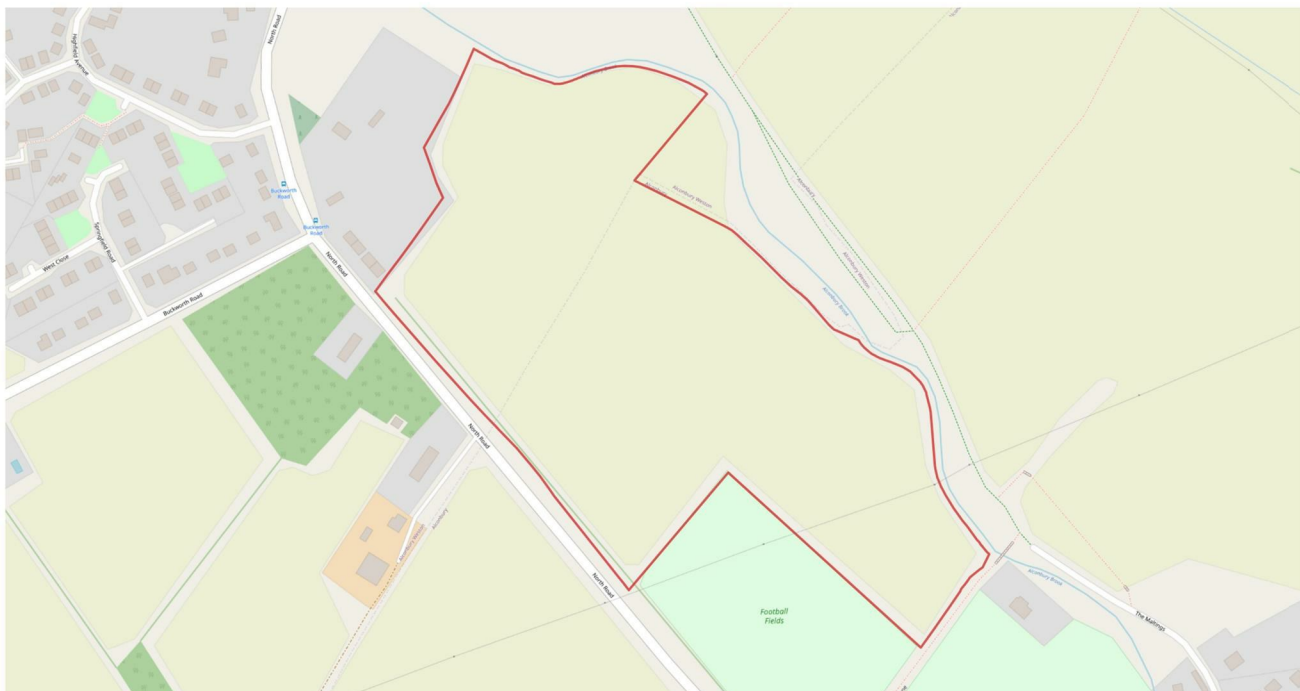
