Location

The property is situated in Fairfield, an established and popular residential district on the north-eastern side of Buxton — the celebrated Georgian and Victorian spa town set high in the Derbyshire hills and widely regarded as the gateway to the Peak District National Park. Rockfield Road lies approximately half a mile from Buxton town centre, where an excellent range of independent retailers, High Street names, cafés and restaurants can be found around the pedestrianised Spring Gardens and The Springs Shopping Centre, alongside the renowned Opera House and the 23-acre Pavilion Gardens. The immediate area is well served by everyday amenities and local schooling, while Buxton railway station — offering regular direct services to Manchester Piccadilly — is within around half a mile, and the wider Peak District countryside is close at hand.
