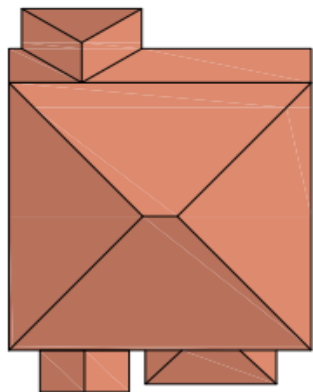
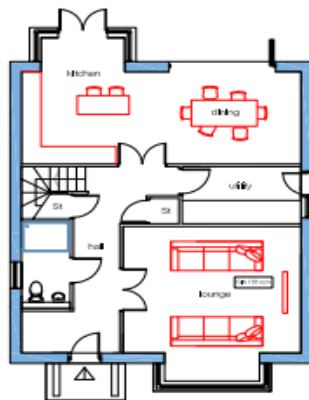
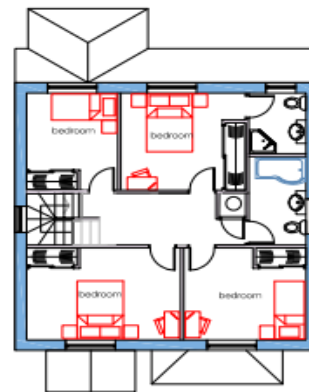




Roof Plan

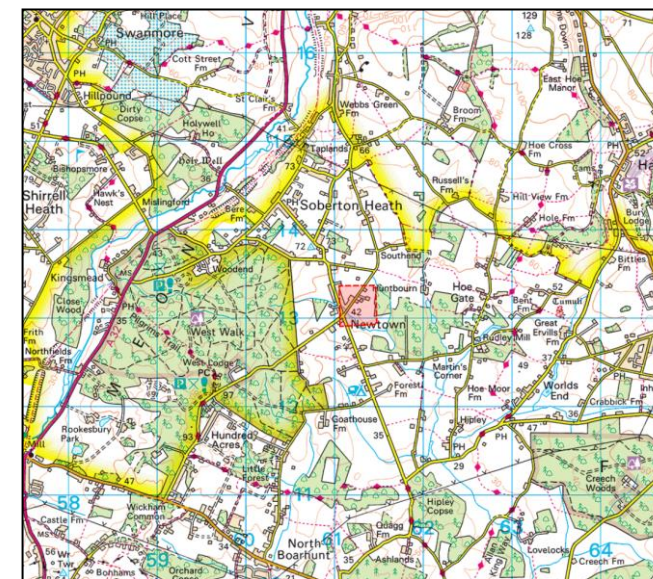
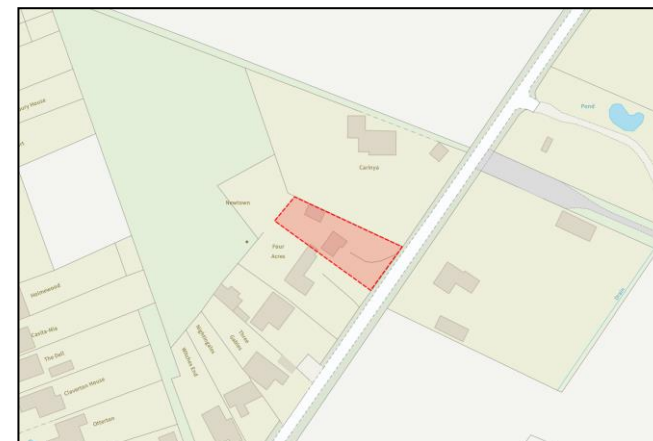

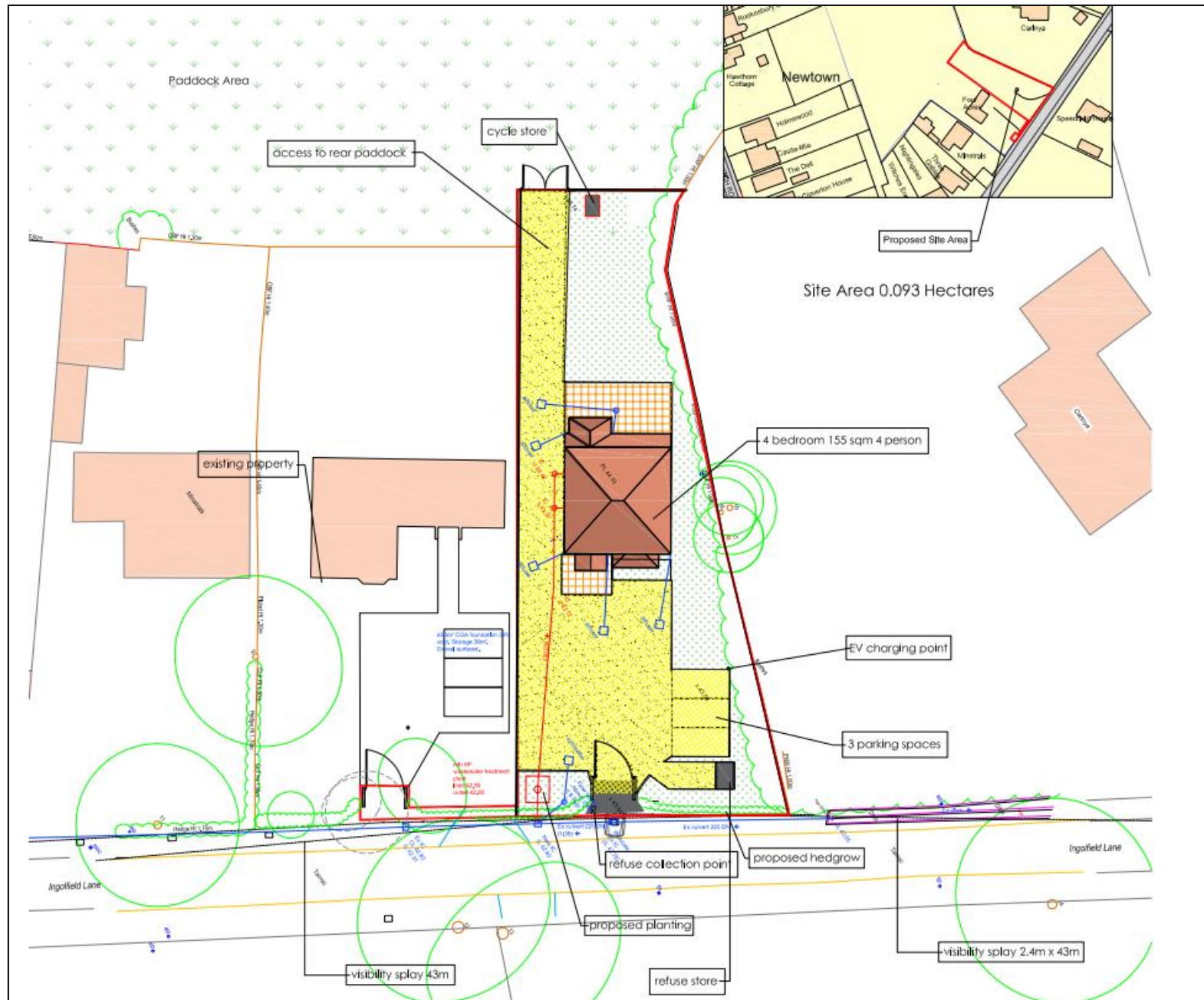
