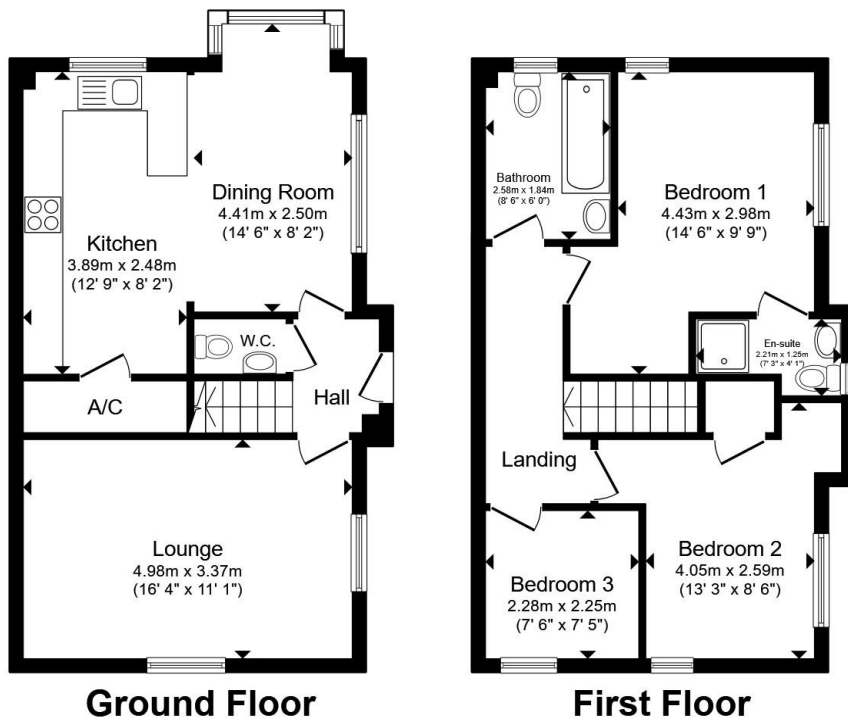




Plot 32 The Osiers, Edwards Way, Manea PE15 0HY
