This three bed semi-detached property situated in Wigmore offers ample off-road parking with driveway together with the added benefit of a garage, providing useful additional storage or secure parking.

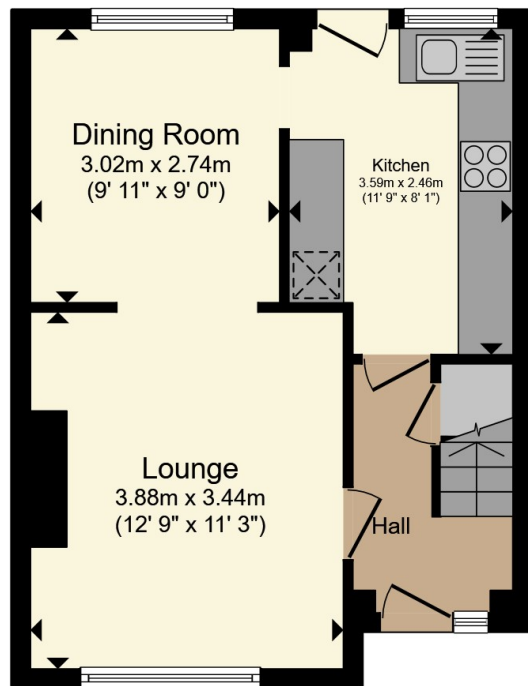

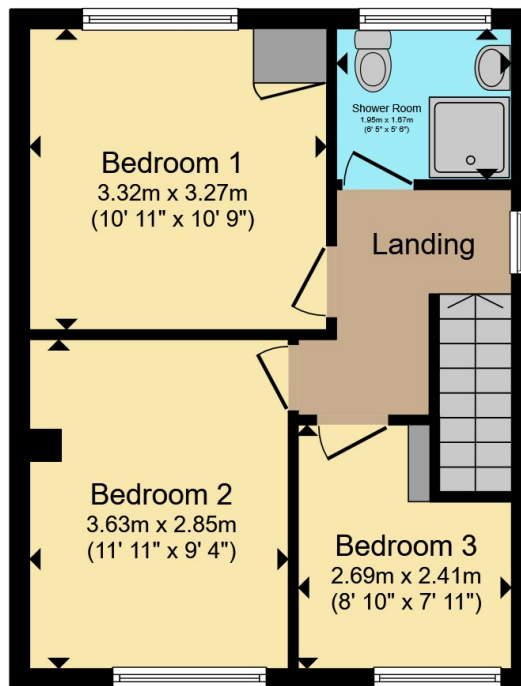
