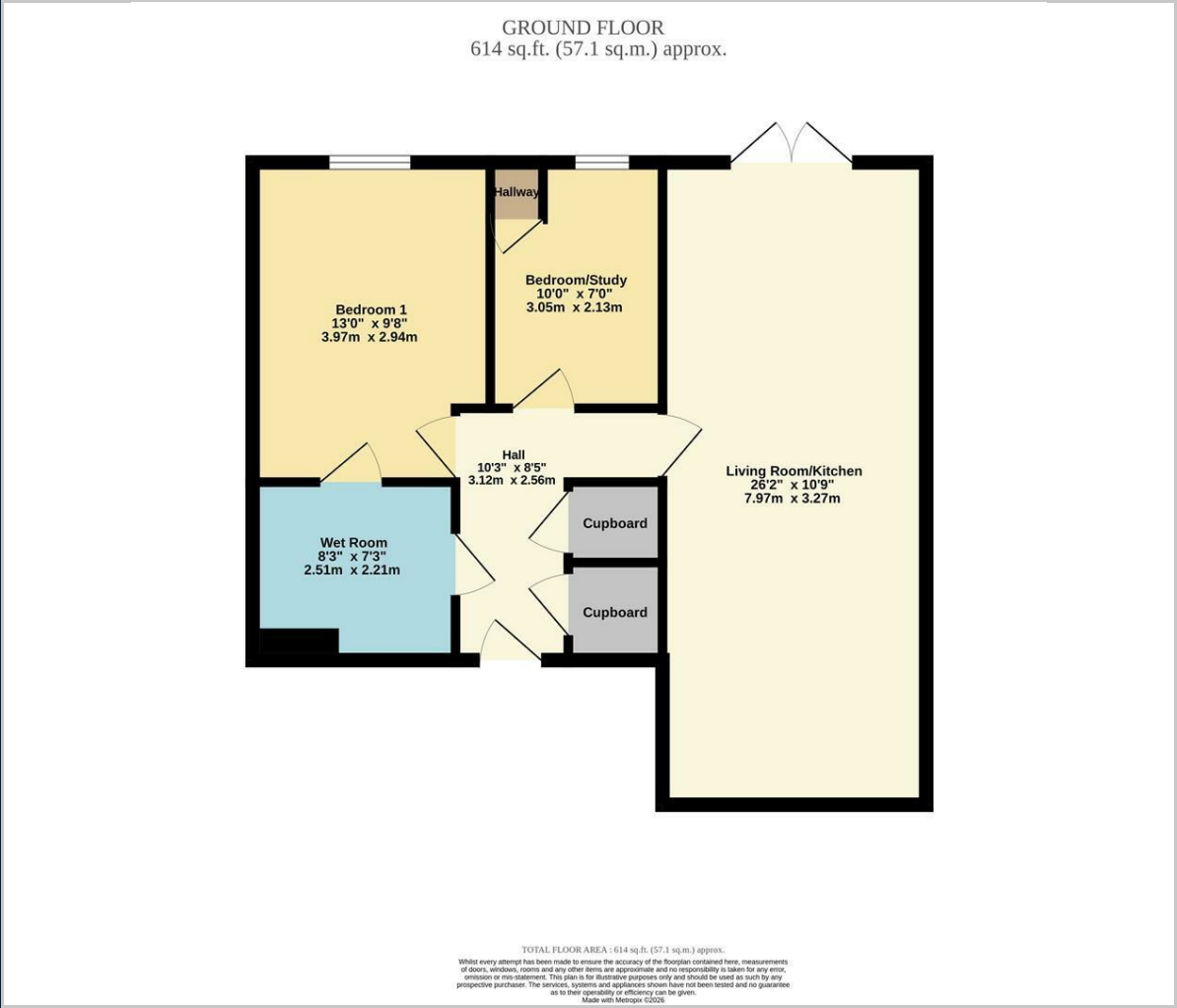

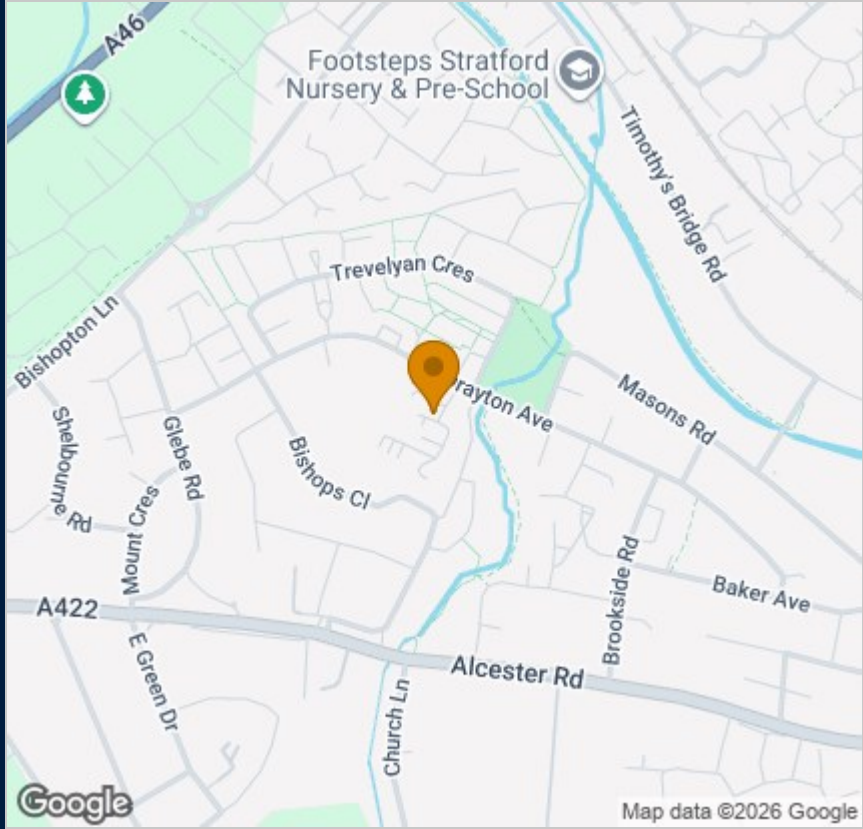

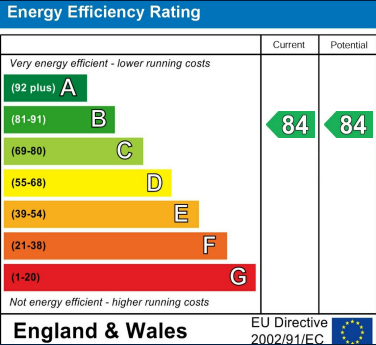
Floor Plan
