Entrance Hall -
Door to front, tiled flooring, open into Lounge/Diner.

Lounge/Diner -
Window to front, tiled flooring continued throughout. A myriad of period features including the standout Inglenook Fireplace and wooden beams. There is access into the kitchen and stairs to the first floor with understairs storage.

Kitchen -
Window to rear, overlooking the courtyard garden. Tiled flooring continued. A range of modern base and wall units, in a traditional shaker style with tiled splashbacks. Integrated oven with gas hob and overhead extractor fan. Stainless steel sink



and wall mounted boiler. Space for washing machine/dishwasher, tumble dryer and fridge/freezer. Stable style door leading out into garden.

Window to rear, tiled flooring continued. A modern, white three-piece suite comprising of panelled bath with screen and shower attachment, pedestal sink and a low-rise WC. Tiled wet zones.

Bedroom Two -

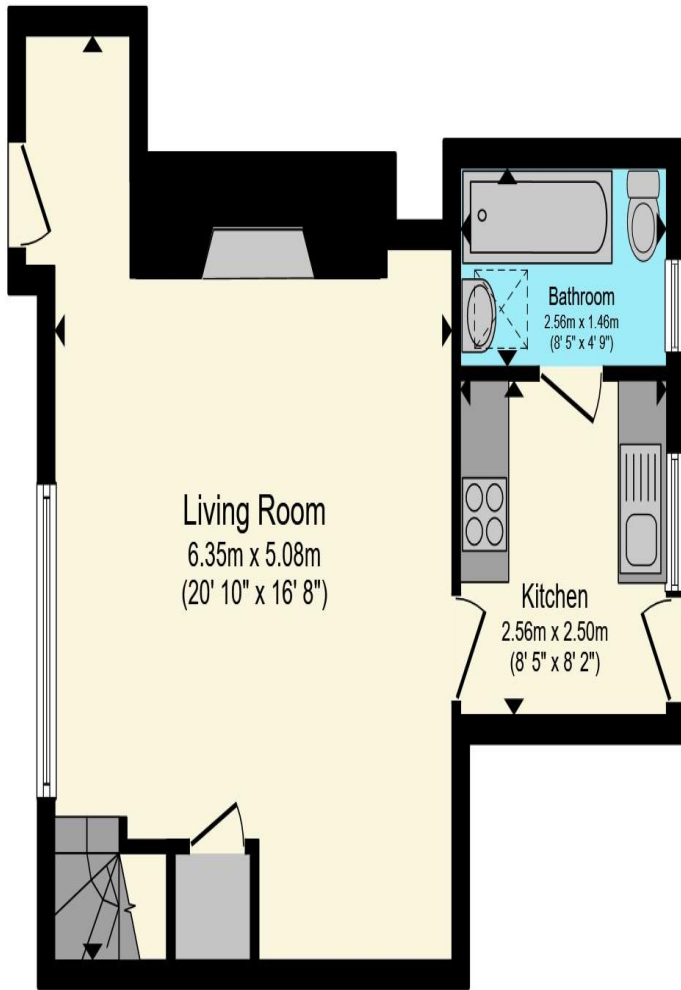
Two Velux windows and fitted carpet.

Outside -

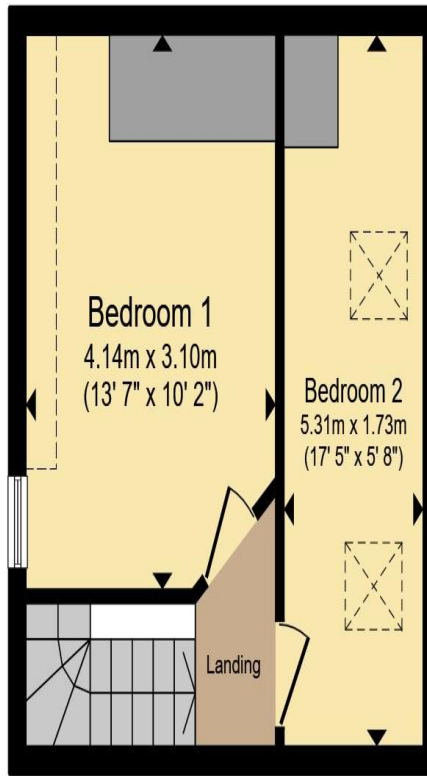
The front on the property steps directly onto Newgate Street. Access into the rear garden via an alley way to the rear.
