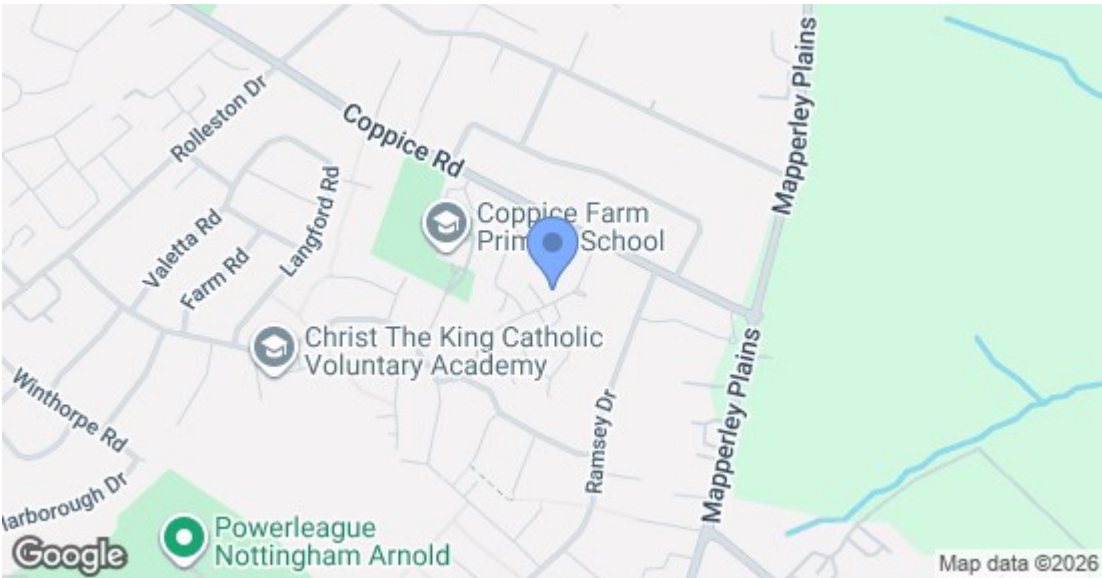

- Anyone on the Council's housing waiting list or eligible to be on it.

Price restriction • The property must be sold at 80% of open market value. • Future resales will also be restricted to 80% of market value.

Council approval • The Council must confirm the buyer meets the eligibility criteria before exchange. • Land Registry will not register the transfer without the Council's certificate.
