The First Homes Scheme is a government-backed initiative designed to help local first-time buyers purchase a home at a significant discount. Eligible buyers can purchase a property for 30% to 50% less than its full market value, making home ownership more affordable.

To qualify, buyers must:

- Be a first-time buyer
- Be aged 18 or over
- Have a household income of £80,000 or less per year (£90,000 in London)
- Obtain a mortgage for at least 50% of the purchase price
- Use the property as their main residence unlike Shared Ownership, buyers own 100% of the property from day one. The discount remains attached to the home when it is sold in the future, helping future generations of first-time buyers benefit too.

50% share price - £170,000

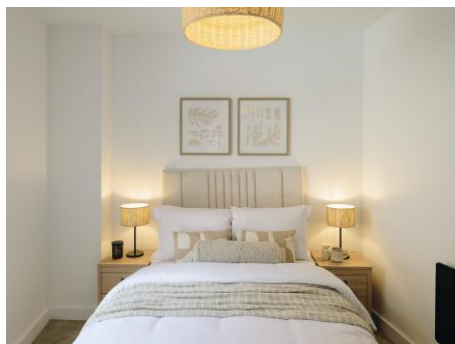
