Situated to the right of the entrance hall, the lounge is a well-proportioned space offering ample room for additional furniture. This room features dual-aspect windows, allowing natural light to flood the area.

The dining room is located to the left, offering a well-proportioned space that can accommodate a large dining table chairs. This versatile room could also serve as a second lounge or a home office.

The kitchen is equipped with a range of wall and base units, providing ample storage, and includes a gas cooker. The flow between the kitchen and dining room creates the perfect arrangement for hosting and entertaining guests.

The ground floor is completed by a W/C.

Ascending to the first floor, you are met by the principal bedroom. This well-proportioned double room offers ample space for additional furniture and benefits from two built-in storage cupboards.

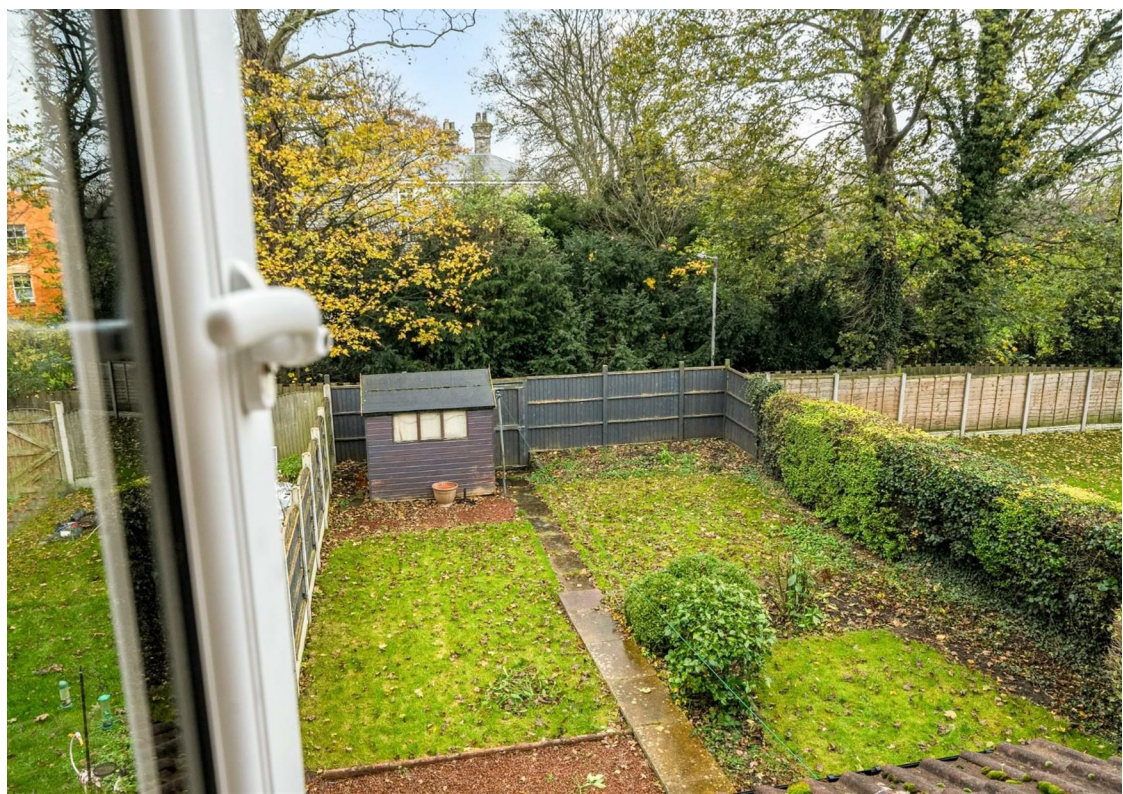
The first floor features two more well-proportioned bedrooms: one double room and one single room.

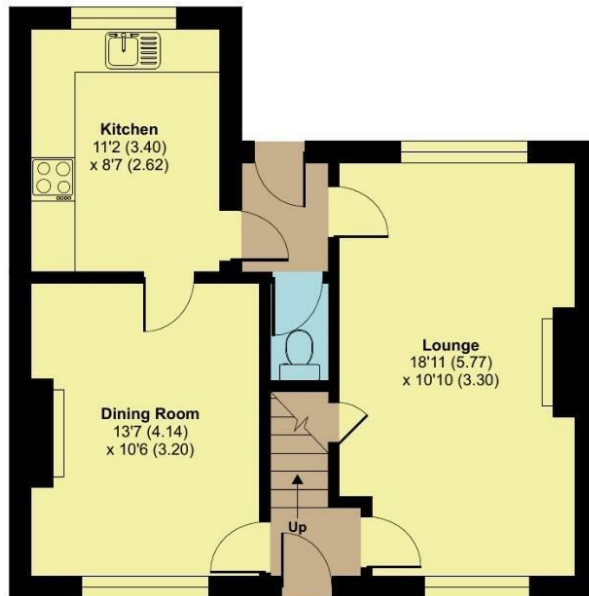




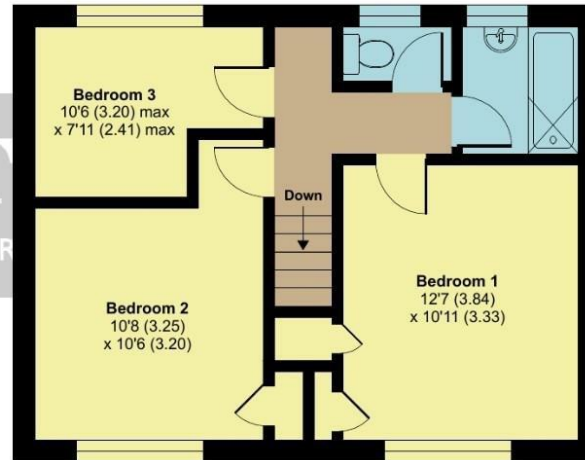
