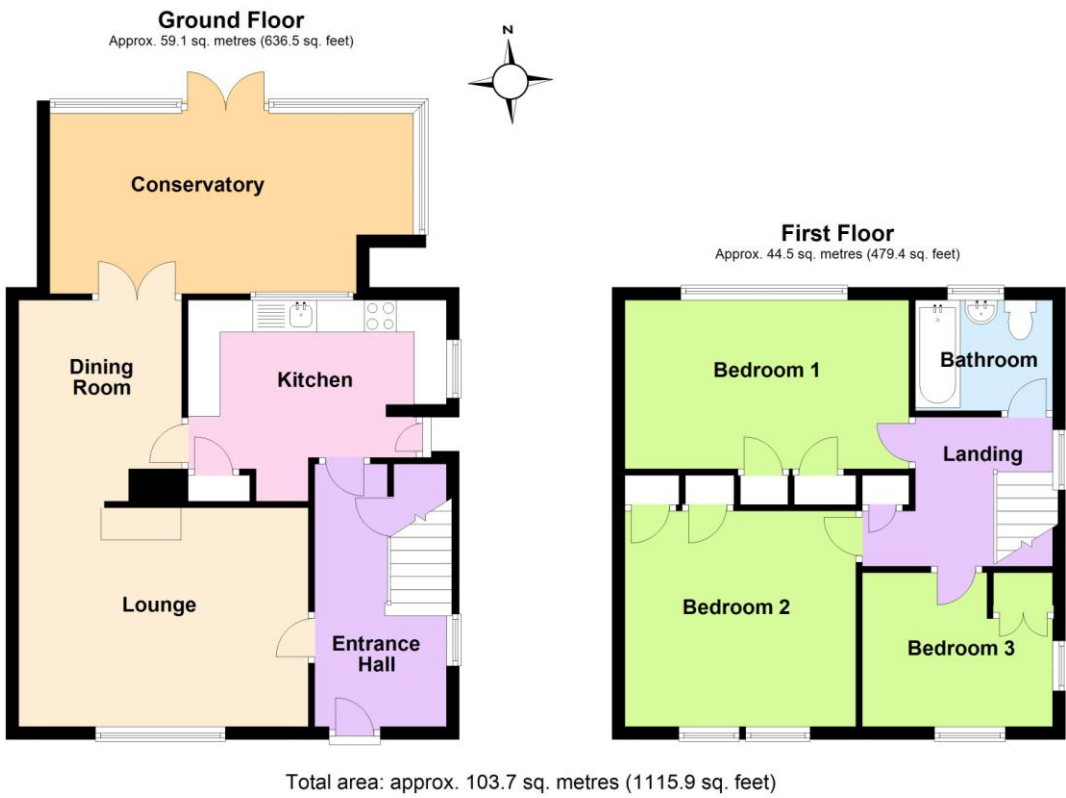

The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, conservatory, three bedrooms, bathroom, gardens to front, rear and side.

Entrance Hall

Stairs rising to first floor landing, window to side aspect, laminate flooring, under stairs storage cupboard, radiator, coving to ceiling, doors to:

Lounge

Window to front aspect, radiator, feature fireplace, through to:

Radiator, French doors to rear aspect, door to:

Comprising stainless steel single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, space for cooker, extractor hood, plumbing for washing machine or dishwasher, tiled splash backs, tiled floor, pantry cupboard, window to rear aspect, door and window to side aspect.

Conservatory

Of brick/uPVC construction, power and light connected, French doors to rear aspect.

Window to front aspect, radiator, built-in cupboard.

Bathroom

Comprising low flush W.C., pedestal wash hand basin, panelled bath with shower over, fully tiled walls, tiled floor, window to rear aspect, heated towel rail.

Outside

Front - Gravelled with bushes and shrubs.

Rear - Patio area, mostly lawn with borders stocked with a variety of shrubs, plants and trees, brick outbuilding (with plumbing for washing machine), enclosed by wooden fencing with gated rear pedestrian access. Measures approx. 125ft max in length. Potential for off road parking via Hayden road, subject to planning permission.
