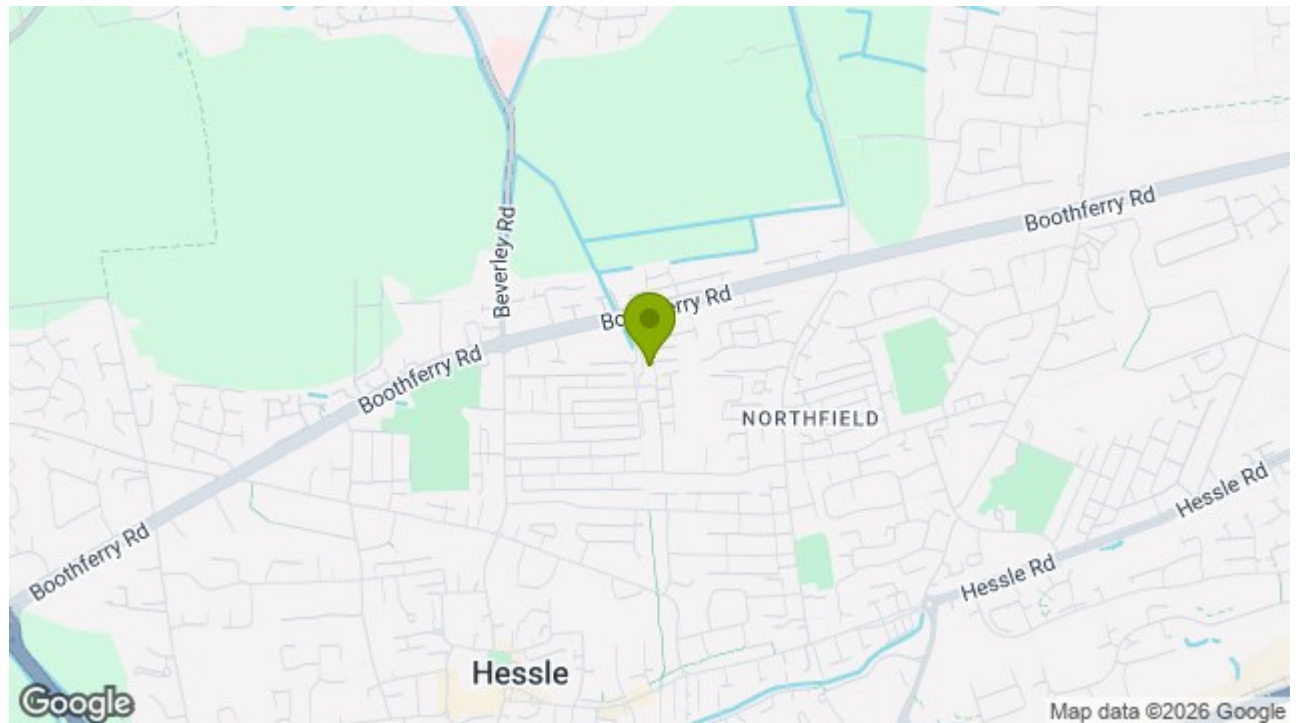
# Penshurst Avenue, Hessle, HU13 9EN

## HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. ## GROUND FLOOR;

### ENTRANCE HALL

Providing access to the accommodation.

### LIVING ROOM

A generous living room with bay window to the front elevation and open to the Dining Area.

A versatile reception space ideal for a dining area with storage cupboard and open to both the living room and kitchen.

### KITCHEN

With shaker style wall and base units, laminated work surfaces and a tiled splashback. Integrated appliances include a Gas Hob, Electric Oven and an Extractor Hood. Further benefitting from plumbing for an automatic washing machine, window and door to the rear elevation.

A bedroom of double proportions with two sets of fitted wardrobes and two windows to the front elevation.

With a three piece suite comprising of a panelled bath with overhead electric shower, a low flush WC and a wash hand basin. Further benefitting from tiled walls, a window to the rear elevation and a radiator.
