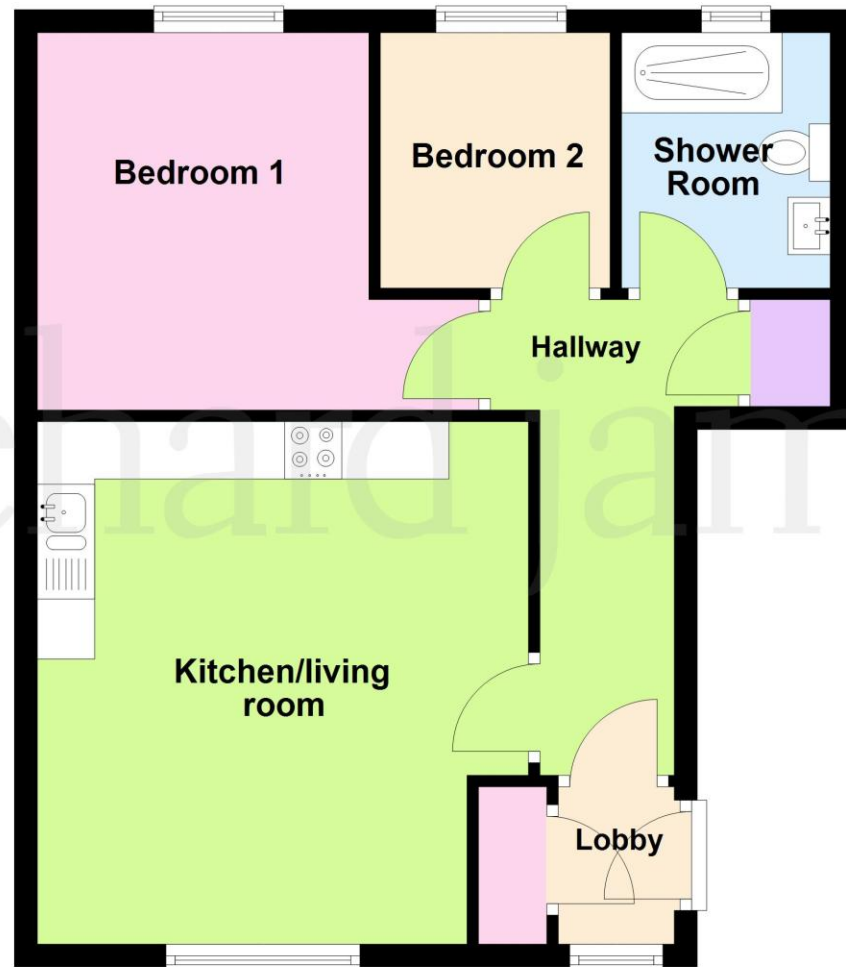


Ground Floor
