LOUNGE

12' 06" x 9' 11" (3.81m x 3.02m) Inset electric live flame fire and beam over. Vertical radiator, wooden and tiled flooring, uPVC double glazed window to front, cupboard housing meter and consumer unit. Door to:

DINING ROOM

12' 05" x 10' 03" (3.78m x 3.12m) Feature iron cast fireplace with wooden surround and mantle, stairs to first floor landing, uPVC double glazed window to rear, wood flooring. Opening to:

REFITTED KITCHEN

9' 11" x 6' 09" (3.02m x 2.06m) Wall, base and drawer unit with work surfaces over, pull out spice drawer and pullout under cupboards, plinth heater, space for fridge/freezer and dishwasher, combi boiler, single drainer sink unit with mixer tap, uPVC double glazed window to side, tiled floor. Opening to:

REAR LOBBY

uPVC double glazed door to side, space for washing machine and plumbing. Door to:

REFITTED FOUR PIECE BATHROOM

Free standing double ended bath with wall mounted mixer tap, low level W/C, circular wash hand basin with cupboard under, extractor fan, heated towel rail, uPVC double glazed window to side.

FIRST FLOOR LANDING

Access to part boarded & Insulated loft space. Doors to:

BEDROOM ONE

9' 11" x 9' 03" (3.02m x 2.82m) Walk in double wardrobe with hanging rails and storage, radiator, uPVC double glazed window to front. Sliding door to:

ENSUITE SHOWER ROOM

Fully tiled shower cubicle, wash hand basin with mixer tap and cupboard under, low level W/C, extractor fan, heated towel rail.

BEDROOM TWO

10' 4" x 9' 05" (3.15m x 2.87m) uPVC double glazed window to rear, vertical radiator.

BEDROOM THREE

9' 11" x 6' 10" (3.02m x 2.08m) uPVC double glazed window to rear, vertical radiator.

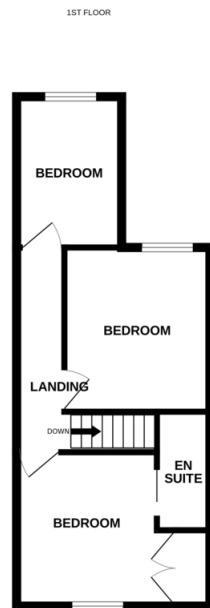
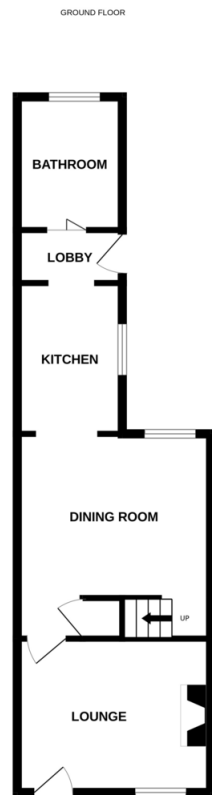
FRONT GARDEN

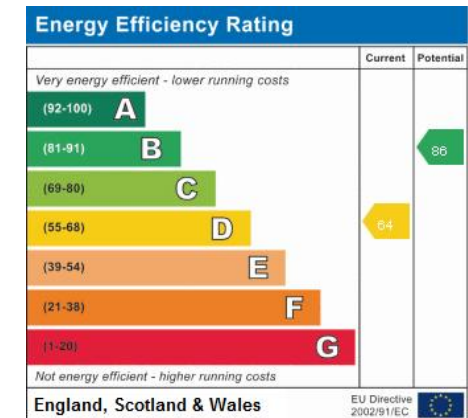
