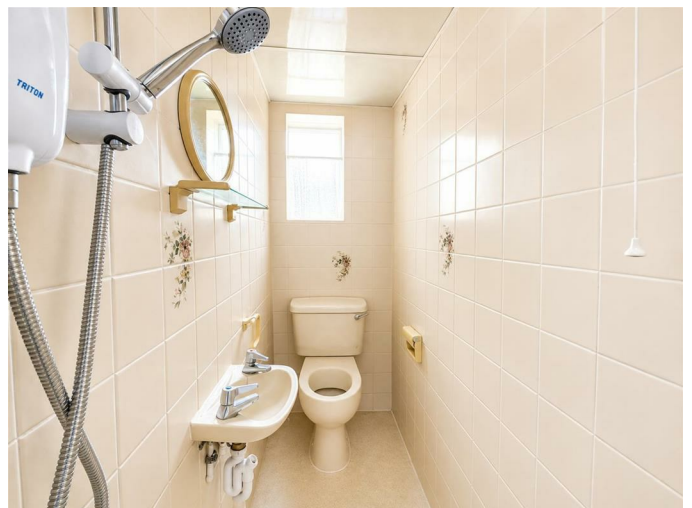

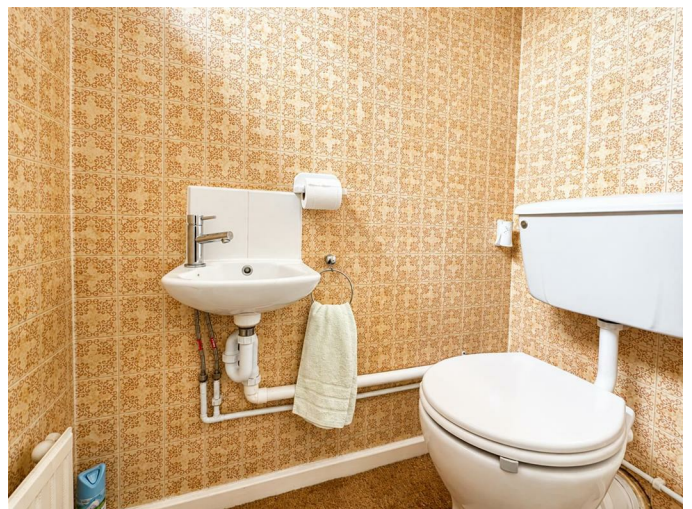

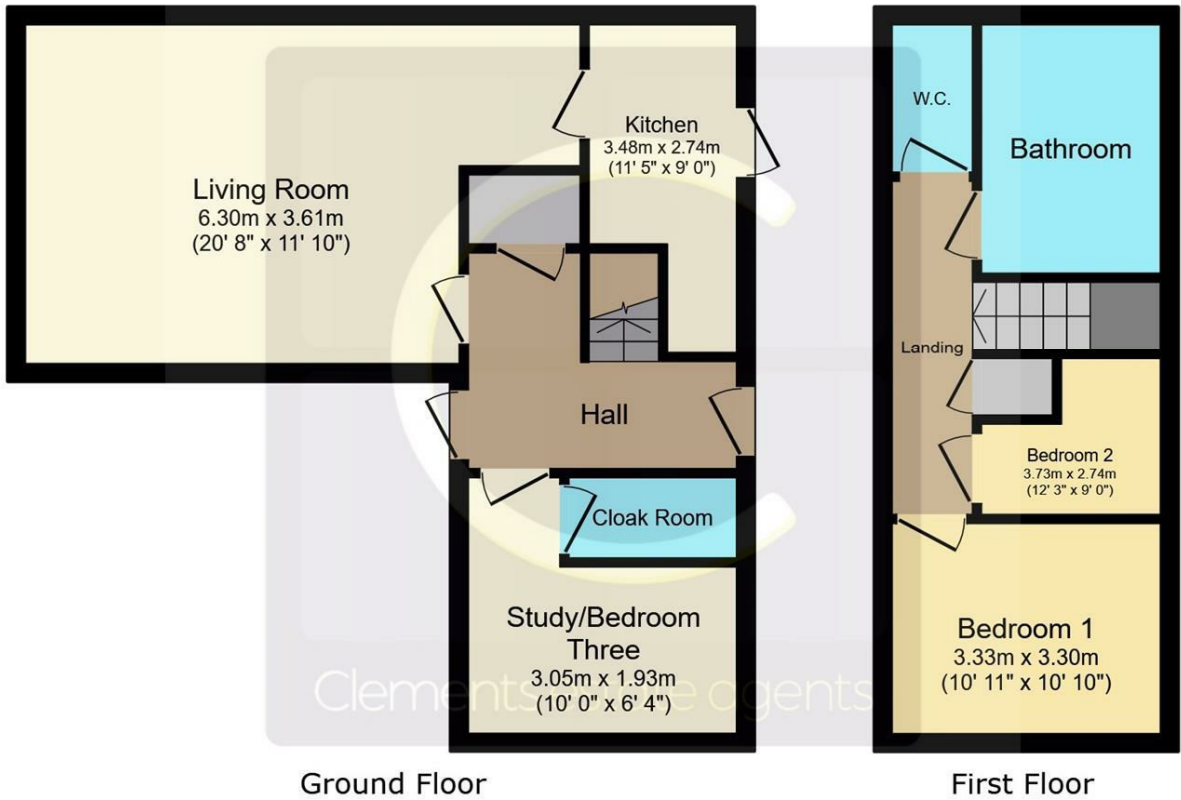

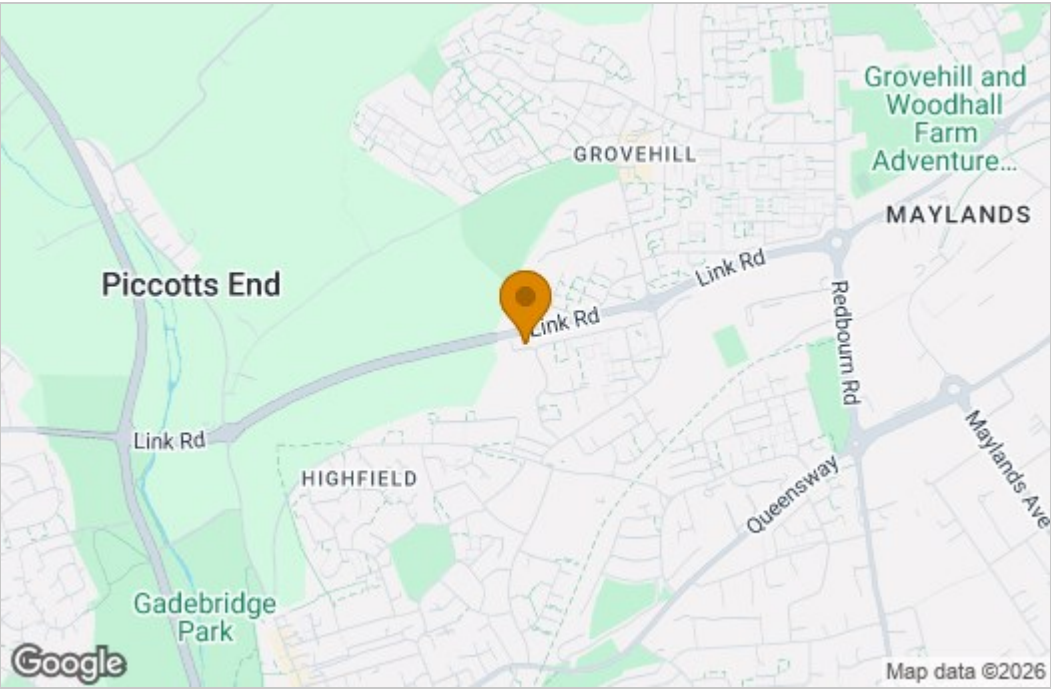

Floor Plan

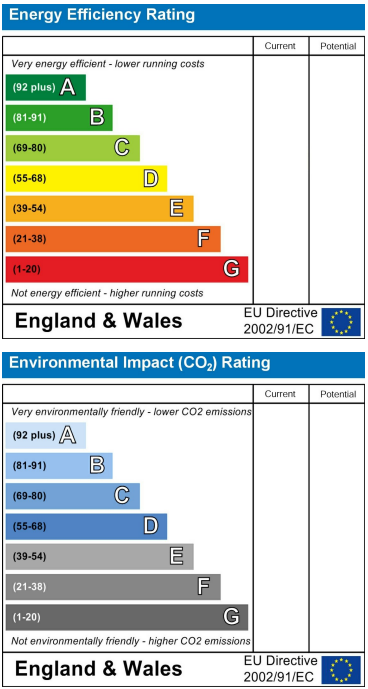
