Property Description

Plumpton Green is a charming and popular village on the edge of the beautiful South Downs National Park and within easy reach of historic Lewes and London Victoria. The village has various everyday amenities including a local shop, four pubs, a wine bar, post office and parish church, as well as a primary school and nursery. The vibrant and historic town of Lewes lies six miles to the south, providing a range of independent shops, supermarkets, restaurants, and recreational facilities. Further schooling is available in the surrounding area, with a state secondary school in nearby Chailey and an agricultural college in Plumpton. Plumpton's station offers services towards London Victoria in approximately 1 hour. London Bridge can be accessed, changing at Haywards Heath. The A27, a short distance away, provides fast access to the A23/M23, Gatwick Airport and the national motorway network.
