1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description Accommodation	The subjects comprise a purpose built, self-contained lower cottage flat forming part of a two storey semi-detached block of four flats. On Ground Floor: Entrance Vestibule, Entrance Hallway, Living Room,
Accommodation	three Bedrooms, Kitchen and Bathroom with WC.
Gross Internal Floor Area (m²)	89 sq m or thereby.
Neighbourhood and Location	The subjects are located in an established residential area of Kirkcaldy originally constructed for public sector letting purposes. Surrounding properties are of a similar style and character. Local shopping and public transport amenities are available in the general area. The subjects lie opposite an amenity green space and lie within proximity of a small burn.
Age (Year Built)	1935
Weather	Dry, being initially sunny and latterly more overcast.

Chimney Stacks	The chimney stacks are of brick construction with a mixture of pointed
	facing brick and render finishes. Flashings are formed in metal.
	Visually inspected with the aid of binoculars where appropriate.
Roofing including Roof Space	The roof is timber pitched, hipped and overlaid with clay tiles. There is a skylight set within the rear roof slope. The roof incorporates valley gutter arrangement within its construction.
	Access to the roof space is entirely private from within the upper flat.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
Rainwater Fittings	Rainwater units are run in a mixture of cast iron and PVC materials.
Kaniwatei rittiilys	Visually inspected with the aid of binoculars where appropriate.

Main Walls The main walls are of cavity brick construction with a mixture of pointed brick and render finishes. Cavity wall insulation has been installed and any related guarantees should be sought. Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and Joinery	Window units are of mixed age replacement uPVC double glazed design. The property is accessed to front and rear by replacement uPVC double glazed doors. There is a retained apparent timber single glazed window unit to the kitchen pantry cupboard, this being painted externally. There is a fixed timber insert panel at the gable elevation. There are some timber eaves areas and some decorative timber detailing to part of the front elevation. Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open.
External Decorations	External decorations are of painted and uPVC finishes.
	Visually inspected.
Conservatories / Porches	Not applicable.
Communal Areas	There are some common circulation areas externally.
	Circulation areas visually inspected.
Garages and Permanent Outbuildings	There is no garage nor garage space. There are no permanent outbuildings.
Outside Areas and Boundaries	The subjects benefit from private front and rear garden grounds, front grounds being partly elevated and accessed by external steps. Boundaries are formed by a mixture of hedging, stone walling and timber fencing.

Ceilings	Ceilings are thought to be of lath and plaster.
	Visually inspected from floor level.

Internal Walls

Internal walls are generally plastered.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors Including Sub-Floors

Flooring is predominantly of suspended timber construction however the vestibule has a solid concrete floor. There is no readily accessible subfloor hatch and hence no sub-floor area inspection could be undertaken.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Internal Joinery and Kitchen Fittings

Internal joinery is of timber with timber internal pass doors, some incorporating glazed inserts, timber door facings and skirtings. The kitchen is fitted with floor and wall mounted storage units. There are some built-in cupboards/storage areas.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Chimney Breasts and Fireplaces

There are chimney breasts within the living room and within two of the bedrooms however bedroom fireplace openings have been removed/blocked over. There is a retained decorative surround within the living room with gas fire fitted.

Visually inspected. No testing of the flues or fittings was carried out.

Electricity	Mains supply. The electrical switch gear is located within a living room wall press.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Water, Plumbing and Bathroom Fittings

Mains water supply. Where seen, plumber work is mainly formed in a mixture of copper and PVC materials. Some localised lead plumber work was however noted within the bathroom. Given the age of the property there is the potential for further older style lead plumber work to exist in concealed areas.

The stopcock is located within a kitchen cupboard. There is a standard kitchen sink unit. The bathroom comprises bath, wash-hand basin and low level WC.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water

There is a wall mounted gas fired combination central heating boiler located within a kitchen cupboard. This supplies steel panelled radiators and also provides domestic hot water.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

All foul and surface water drainage is assumed to be connected to the main public sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

Only the subject flat and internal communal areas giving access to the flat were inspected.

If the roof space or under-building / basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation.

The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

Our inspection was restricted to the exposed and accessible surface fabric.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

No inspection was possible of any roof void area as access is taken entirely privately from within the upper flat.

A restricted inspection was possible only of the roof and chimneys from ground level.

Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.

Restricted inspection in cupboards due to storage items.

At the time of inspection the subjects were unoccupied, part furnished and floors throughout were covered. The services were not tested.

There is no readily accessible sub-floor hatch and hence no sub-floor
area inspection could be undertaken.

Notes	There is some general deterioration to the chimney stacks including weathering to render and brickwork, worn pointing and cracked coping. It should be appreciated that these are of an age where ongoing maintenance will be required, particularly to flashing details to ensure water tightness.

Repair Category	2
Notes	The roof coverings appear to be the original and are showing signs of deterioration including weathering to tiling and damaged pointing. Some ridge and hip detailing is worn. There are some moss coverings which should ideally be removed.
	The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.
	There is deterioration to the skylight which will require vigilant ongoing maintenance attention.

	Rainwater Fittings

Notes	There is corrosion affecting rainwater units are there are flaking paintwork finishes. There is some staining to render finishes adjacent to downpipes indicative of leakage. Corrosion can result in leakage. Attention is required to areas of the rainwater goods system where deterioration has occurred.

	Main Walls
Repair Category	2
Notes	The external ground level is high in relation to some of the sub-floor ventilators and should be lowered to prevent associated defects occurring. There is deterioration to facing brick base course areas including to pointing. There is localised damp staining to render finishes together with sections of cracked render. There is some cracking to external sills.
	Repairs in these regards should be envisaged as part of an ongoing maintenance programme.



Windows, External Doors and Joinery

Repair Category	2
Notes	Replacement window units are generally of an older style and are showing deterioration including to seals. Some draught proof strips have been installed to a bedroom window unit. A number of hopper window unit handles are stiff thus preventing these from being secured/locked. The need for repairs should therefore be anticipated.
	There is weathering to a retained window unit within the kitchen pantry cupboard and to a fixed timber panel at the gable.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.
	Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.

Notes	The external decoration is weathered and an overhaul should be expected.

Notes	The communal areas serving the property appear to be adequately maintained.

Notes	Not applicable.

	Outside Areas and Boundaries
Repair Category	2
Notes	There are sections of worn and off-plumb fencing. Some deterioration was noted to low retaining brick walling within the front garden and around the front garden entrance steps.
	Outside areas and boundaries will require ongoing repairs and maintenance.
	The boundaries appear reasonably well defined. Regular maintenance will be required. You should verify with your conveyancer the extent of the boundaries attaching to the property.

	Ceilings
Repair Category	2
Notes	It is assumed that timber ceiling linings within the kitchen and bathroom have a suitably fire retardant finish.
	Some decorative surfaces are finished with an Artex type product. Early forms of Artex may incorporate small amounts of asbestos based bonding materials and therefore specialist advice should be obtained prior to working on these areas to minimise the risk of releasing hazardous fibres.
	Cracking and blemishes have occurred and some plaster repairs may be required.

Notes	The internal walls are largely covered with decorative finishes. During routine
	redecoration some plaster filling may be necessary.

Notes	There are some sections of loose and creaking flooring.

	Internal Joinery and Kitchen Fittings

Notes	Insert glazing to pass doors is not safety glass stamped and should ideally be replaced in a safety glass equivalent.
	The internal joinery is showing some signs of wear and tear and upgrading during routine decoration is thought necessary.
	Kitchen fittings are worn and dated and require upgrading/replacement.

	Chimney Breasts and Fireplaces
Repair Category	2
Notes	There is a gas fire within the living room. This has an associated advisory ticket stating that the fire appliance should not be used. A Gas Safe registered heating engineer can provide further advice in this regard. Where original fireplaces have been removed/blocked we assume these have been
	adequately vented.

Notes	The property is reasonably decorated although it is recognised that on taking occupancy, homeowners will likely consider redecoration or refurbishment to suit individual tastes and requirements.

Notes	Not applicable.

	Electricity
Repair Category	2
Notes	The fuse box has been adapted. Single sockets would not comply with current Regulations and there is limited power point provision. The electrical installation is of mixed age and includes a number of older sections. It will be necessary to have the installation checked by a suitably qualified electrician and upgraded as necessary.
	The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

Notes	In the interest of safety all gas appliances should be checked by a Gas Safe Registered Engineer.
	The gas meter box cover requires reinstatement.

	Water, Plumbing and Bathroom Fittings
Repair Category	2
Notes	There is some softening to flooring adjacent to plumber work within the bathroom. Some moisture was recorded to surfaces adjacent to plumber work within the kitchen indicative of leakage. A plumbing contractor can inspect and carry out any necessary works of upgrading. Lead plumber work was noted within the property and there is the possibility of further older style sections in concealed areas. It would be prudent to budget for upgrading in conjunction with other modernisation works. Where the plumbing and fittings appear of copper/pvc piping these appeared in serviceable condition but were not tested. The sanitary fitments are showing typical signs of age-related wear and tear. As such, there is an increased risk of water spillage to concealed areas. It would therefore be prudent to check all surrounding seals/tiling/finishes to ensure that the bathroom remains in a watertight condition. We were unable to view concealed areas below sanitary fitments.

Notes	There is a gas fired central heating system and gas fittings and these should all be checked and serviced in the normal manner. In the interests of safety it would be prudent to have all gas appliances checked by a Gas Safe registered tradesperson. Unrestricted parking within 25 metres: For this purpose, 'Unrestricted parking' includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coinoperated machines.

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We assume that the carriageways etc., ex adverso the subjects are the responsibility of the Local Authority.

The subjects form part of a block of flats and it has been assumed that maintenance/repair costs of the common parts of the building and external grounds will be shared on an equitable basis with the adjoining proprietors. It is therefore assumed that the costs of repairs detailed within this report which relate to these areas should be apportioned accordingly, although exact liability should be confirmed.

There are some common external circulation areas. The conveyancer should verify that all legal arrangements are adequate.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the installation of replacement double glazed window units and doors.

Estimated Reinstatement Cost for Insurance Purposes

£285,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £285,000 (TWO HUNDRED AND EIGHTY-FIVE THOUSAND POUNDS STERLING).

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £100,000 (ONE HUNDRED THOUSAND POUNDS STERLING).

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.



1.3 Liability

- the Seller
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following: a) 25% of the valuation or b) £250,000.

1.4 Generic Mortgage Valuation Report

The Surveyors undertake to the Seller that they will prepare a Generic Mortgage Valuation Report, which will be issued along with the Report. It is the responsibility of the Seller to ensure that the Generic Mortgage Valuation Report is provided to every potential Purchaser.

1.5 Transcript Mortgage Valuation for Lending Purposes

1.6 Intellectual Property

All intellectual property rights whatsoever (including copyright) in and to the Report, excluding the headings and rubrics, are the exclusive property of the Surveyors and shall remain their exclusive property unless they assign the same to any other party in writing.

1.7 Payment

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. If our account details change, we will notify these to you by letter or face to face and never by email.

1.9 Precedence

If there is any incompatibility between these Terms and Conditions and the Report, these Terms and Conditions take precedence.

1.10 Definitions

- the "Lender" is the party who has provided or intends or proposes to provide financial assistance to the Purchaser towards the purchase of the Property and in whose favour a standard security will be granted over the Property;
- the "Transcript Mortgage Valuation Report for Lending Purposes" means a separate report, prepared by the Surveyor, prepared from information in the Report and the generic Mortgage Valuation Report, but in a style and format required by the Lender. The Transcript Mortgage Valuation Report for Lending Purposes will be prepared with the skill and care reasonably to be expected from a Surveyor who is a member of the Royal Institution of Chartered Surveyors and who is competent to survey, value and report on the Property;
- the "Generic Mortgage Valuation Report" means a separate report, prepared by the Surveyor from information in the Report but in the Surveyor's own format.

DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.

WARNING

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. This is particularly true during slow market conditions when the effect can be considerable. Parts of the Property which cannot be seen or accessed will not be reported upon and this will be stated. If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors

2.4 Services

Surveyors are not equipped or qualified to test the services and therefore no comment can be interpreted as implying that the design, installation and function of the services are in accordance/compliance with regulations, safety and efficiency expectations. However, comment is made where there is cause to suspect significant defects or shortcomings with the installations. No tests are made of any services or appliances.

2.5 Accessibility

A section is included to help identify the basic information interested parties need to know to decide whether to view a Property.

2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation within a willing buyer and willing seller in an arms-length transaction after proper marketing wherein the parties have each acted knowledgably, prudently and without compulsion. In arriving at the opinion of the Market Value the Surveyor also makes various standard assumptions covering, for example, vacant possession; tenure and other legal considerations; contamination and hazardous materials; the condition of uninspected parts; the right to use mains services; and the exclusion of curtains, carpets etc. from the valuation. In the case of flats, the following further assumptions are made that:

- There are rights of access and exit over all communal roadways, corridors, stairways etc. and to use communal grounds, parking areas, and other facilities;
- There are no particularly troublesome or unusual legal restrictions.
- There is no current dispute between the occupiers of the flats or any outstanding claims or losses; and the costs of repairs to the building are shared among the co-proprietors on an equitable basis.

MORTGAGE VALUATION - CONDITIONS OF ENGAGEMENT

"Agreement" means these Terms and Conditions of Engagement, the Instructions and the confirmation letter issued by Graham + Sibbald.

"Client"/"you"/"your" means the person, firm, company, organisation or other entity engaging Graham + Sibbald to provide the inspection services.

"Instructions" means the written or verbal instructions by the Client to Graham + Sibbald, which appoint Graham + Sibbald to provide the inspection services.

"Property" means the property identified and described in the Instructions.

"UK Data Protection Legislation" means all applicable data protection and privacy legislation in force from time to time in the UK including the UK GDPR; the Data Protection Act 2018; the Privacy and Electronic Communications Directive 2002/58/EC (as updated by Directive 2009/136/EC) and the Privacy and Electronic Communications Regulations 2003 (SI 2003/2426) as amended.

"UK GDPR" has the meaning given to it in section 3(10) (as supplemented by section 205(4)) of the Data Protection Act 2018.

A valuation for mortgage is a limited inspection and report produced for building societies, banks and other lenders to enable them to make a lending decision. IT IS NOT A SURVEY. Unless otherwise stated the date of valuation will be the date of inspection.

This report is used to guide the lender on the market value of the Property for mortgage purposes and is carried out for this purpose alone. Although the inspection will be carried out by a valuer who will usually be a qualified surveyor it is not a detailed inspection of the Property, and only major visible defects will be noted. 



The energy efficiency rating of your home
