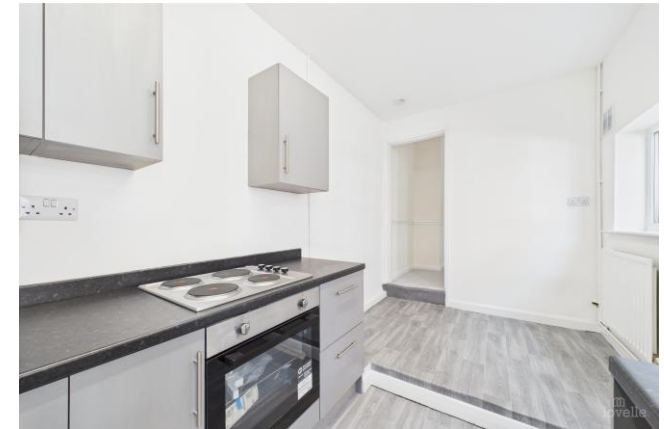

This traditional terraced property is ideal for those looking for their first home, to add to their property portfolio, or those looking to downsize.

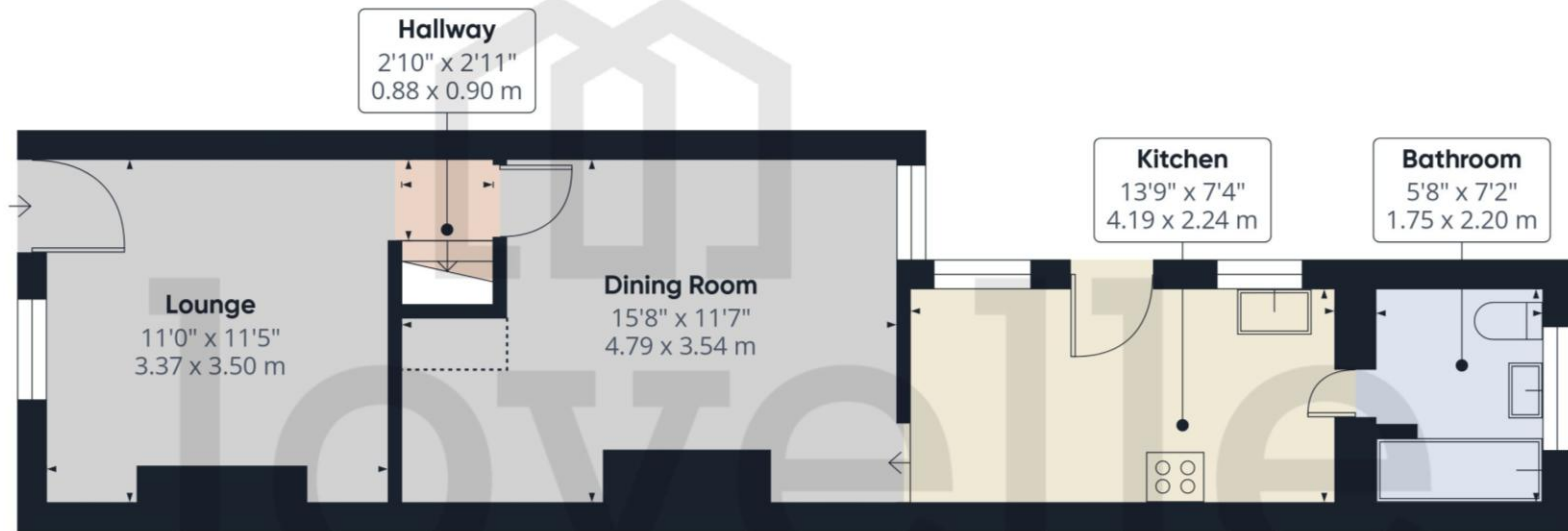

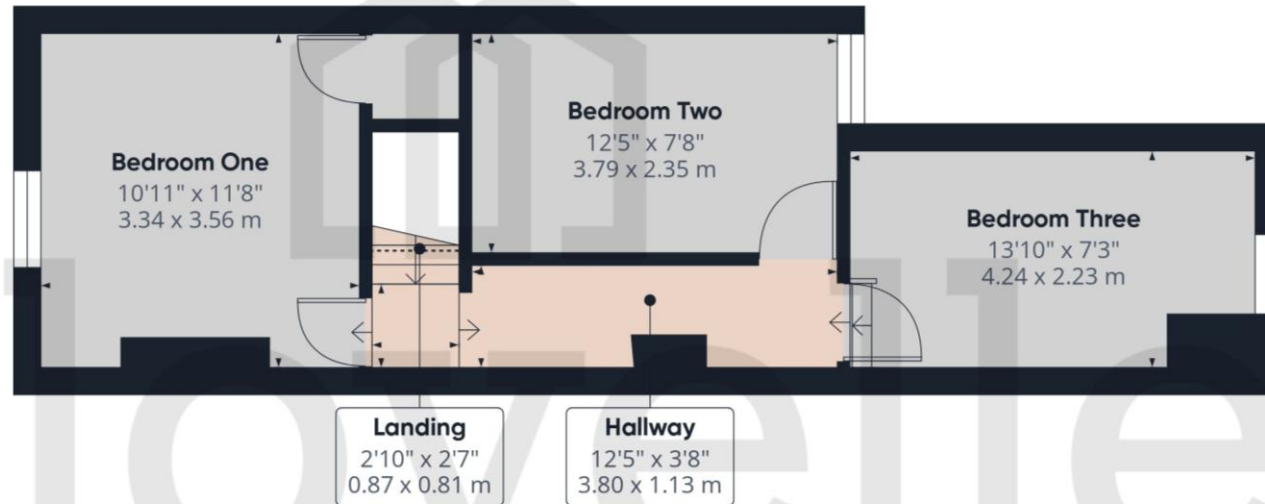
