PROPERTY DESCRIPTION

A beautifully presented modern three double-bedroom detached bungalow built in 2017, situated in a secluded, level position at the end of a quiet, popular residential cul-de-sac, within close proximity to Crownhill Village and its amenities. The living accommodation, which is beautifully presented throughout in tasteful neutral colours, comprises an entrance porch, an open-plan living area incorporating the lounge with a vaulted ceiling and dining area, both with patio doors opening onto an attractive decked seating area. There is a modern fitted kitchen with a host of integrated appliances, a modern family bathroom, a useful utility room, and three double bedrooms, the master benefiting from an en-suite shower room.


The property stands on a well-maintained, level plot that incorporates front, rear, and side gardens, and a private driveway offering parking for several vehicles.

The bungalow also benefits from underfloor heating and PVCu double-glazed windows and doors throughout. An internal viewing is highly recommended to truly appreciate this wonderful family home.

CROWNHILL

This mostly 1930's suburb grew around the junction of the A386 Tavistock Road and the A374 road (later the A38 and now the B3413) from Plympton to Saltash Passage. Following realignment of the A386 in the 1970s, the old Tavistock road has been isolated and renamed Morshead Road. There is a pub, a M & S food outlet, a post office, a few convenience stores, many takeaways and an Indian restaurant. Crownhill is the home of the divisional police headquarters and a Catholic boy's comprehensive school. Primary schools include Eggbuckland Vale, St Edwards, Widey Court. Notre Dame Catholic Girls School, is located within 1.5 miles of Crownhill. There is also a large fire station and close by a big garden centre. The district is very popular because it is very close to the A38 Parkway/Devon Expressway and is near to the local general hospital at Derriford without being so far from the city centre, four miles south, that it is isolated and inaccessible as are so many of Plymouth's satellite suburbs.
