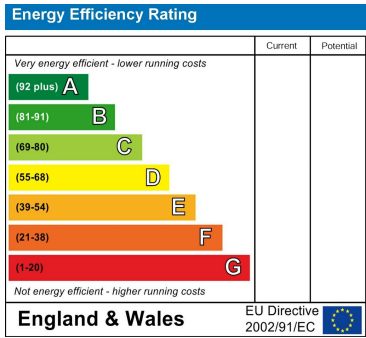
Floor Plan
