Take the Morda road out of Oswestry and at the junction with the A483 turn right. Pass through the villages of Pant and Llanymynech and proceed until reaching Four Crosses. Take the first left at the roundabout and then left again. Proceed past the petrol station and then at the mini roundabout take the first exit. Proceed straight ahead where the site will be found on the left hand side.

- Water services to be split off below floor into separate supplies for Fire Sprinkler system
- Boundary fences will be erected with Sound Barrier Fence to rear boundary against by-pass
- The Access roadway will be constructed to a porous surface finish with footpath to one side of road

Money Laundering Regulations

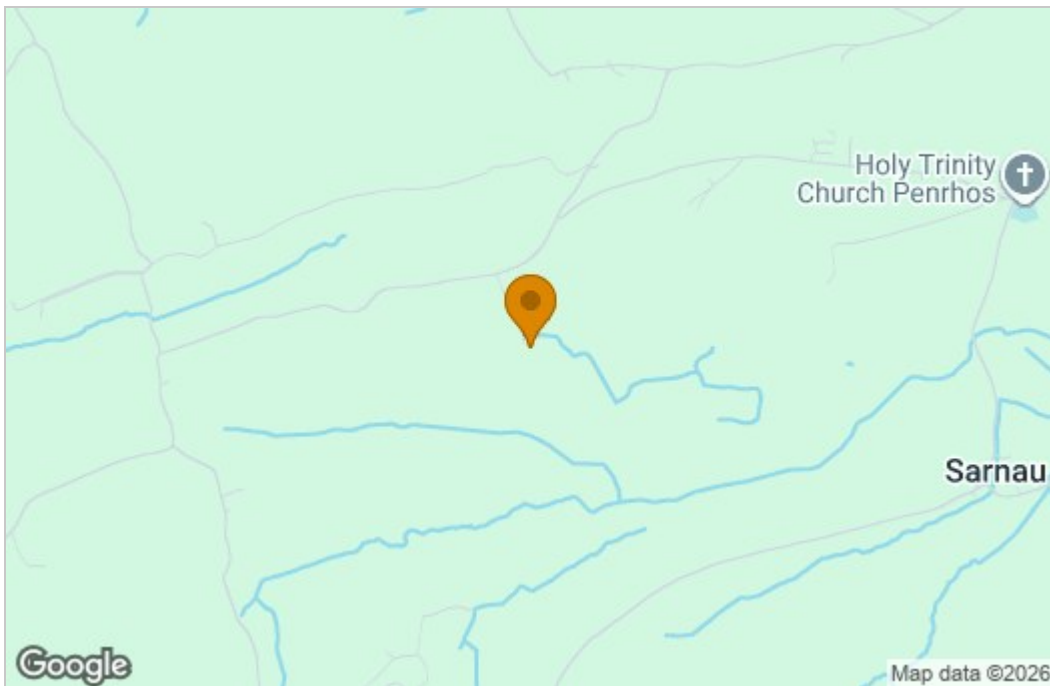

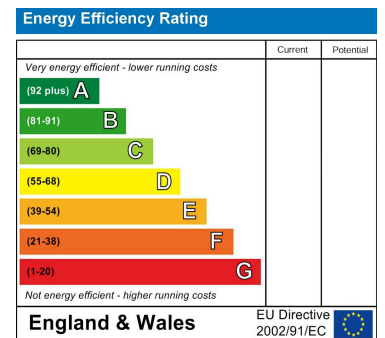
