The open-plan living and dining area is bathed in natural light, framed by a set of striking full-height windows bespoke kitchen is finished to a superb standard, with oak veneer base units, liquid metal-effect upper cabinets, and integrated LED lighting that opens out onto a balcony which overlooks the gardens, offering the perfect spot for morning coffee or evening drinks. A Calacatta porcelain slab serves as both the worktop and splashback, paired with a full suite of integrated Miele appliances for a seamless, modern aesthetic.

The principal bedroom suite includes a generous walk-in wardrobe area and a beautifully appointed en suite bathroom, finished in Neolith Calacatta Gold porcelain to the floors and shower enclosure, Savannah polished limestone to the walls and vanity tops, and a bespoke timber veneer vanity unit with reeded antique detailing.



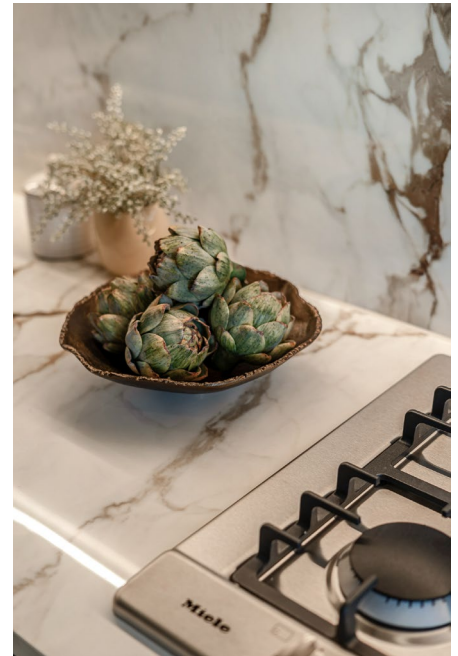


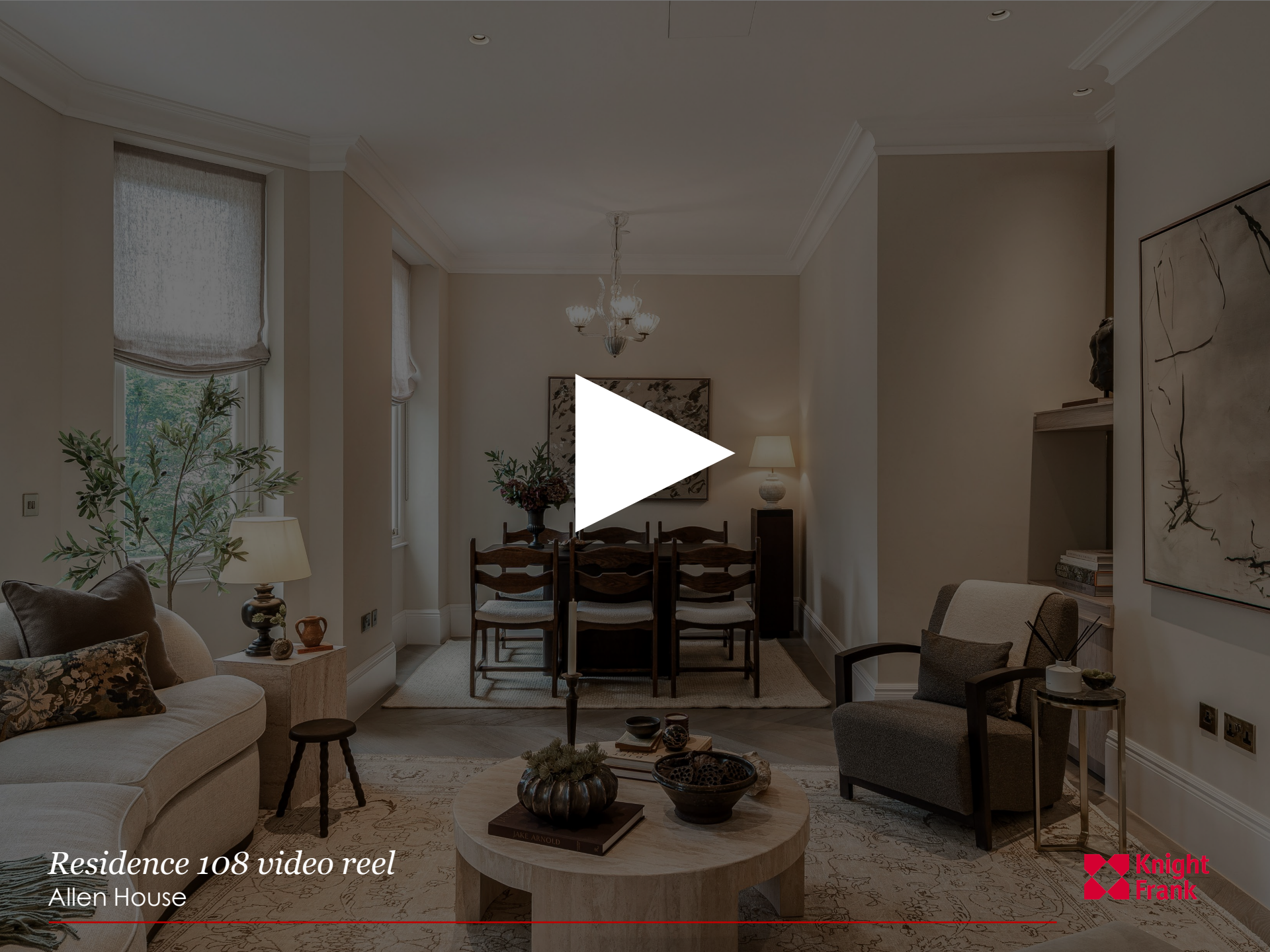
