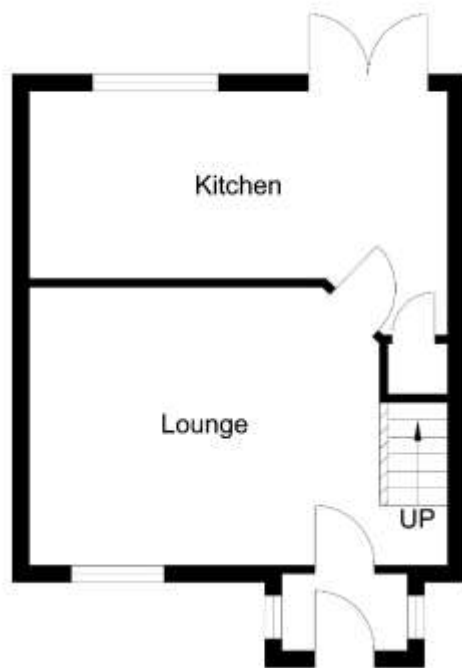

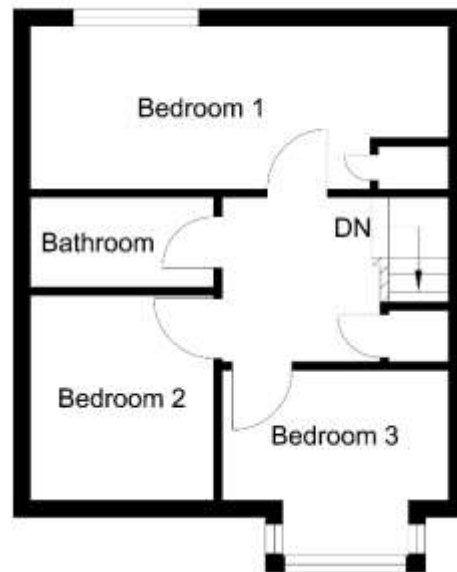

Ground Floor

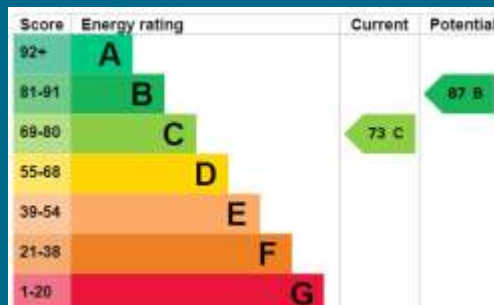
