The ground floor comprises a welcoming entrance hall, a generous dual aspect lounge ideal for relaxing and entertaining, a separate dining room, fitted kitchen, utility room and a convenient cloakroom/WC.

To the first floor are three well-proportioned bedrooms, all served by a family shower room accessed from the landing.

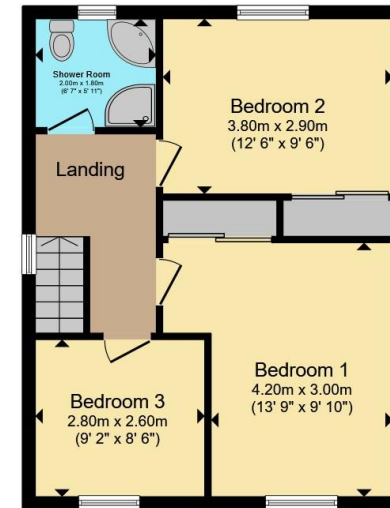
