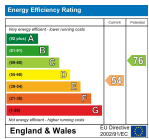
SITUATION

Chilthorne Domer is a small village located to the north of Yeovil. There is a popular pub and primary school. The closest town Yeovil is the main town in an area with a wide range of excellent shopping, business and cultural facilities. There are numerous supermarkets as well as schools from primary through to secondary and a college. A mainline rail station is at Yeovil Junction with road links placed jointly on the A30 and A37. Yeovil Pen Mill station serving the Weymouth to Bath line is a short distance from the property. The A303 trunk road is approximately 5 miles away. The M5 Junction 23 is circa 20 miles and the South Coast within 25 miles.
