Timber entrance door accessing the living room

LIVING ROOM

12' 5" x 11' 5" (3.78m x 3.48m)

Entered via a solid oak front door with inset single glazed panel, adjacent uPVC double glazed window to the front elevation, ceiling rose, electric fireplace and recess shelving.

KITCHEN DINER

12' 8" x 8' 1" (3.86m x 2.46m)

The kitchen has a range of wall and base units with ceramic tiled flooring, sink and drainer unit, tiled splash backs, four ring electric hob, extractor hood over, electric oven and grill, space and plumbing for multiple appliances. Also enjoying a uPVC double glazed window to the rear elevation and further uPVC framed door accessing the private rear garden.

Stairs ascending to the first floor landing grants access to two bedroom and shower room. Loft hatch (insulated loft)
