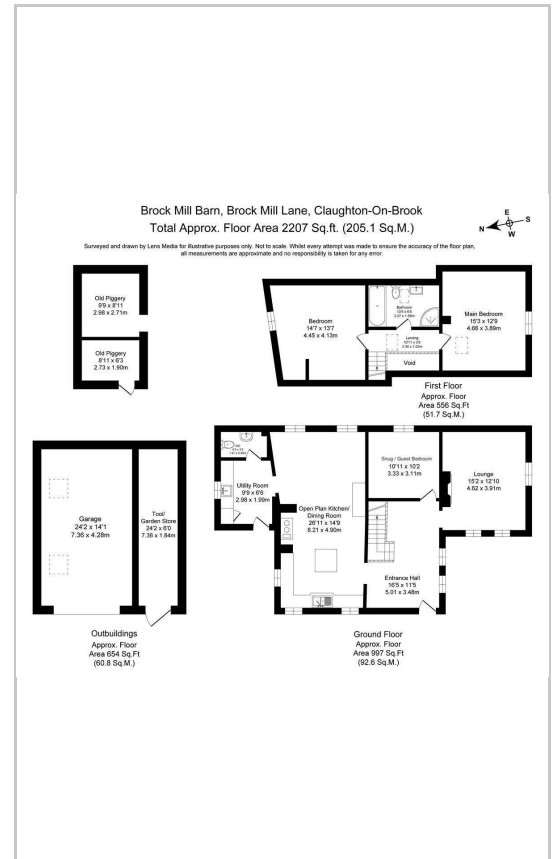

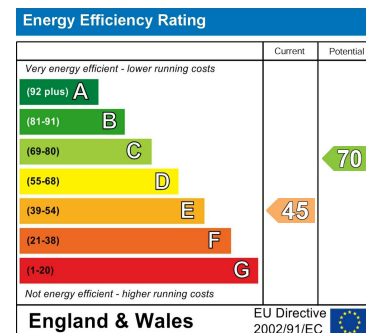
## Area Map
