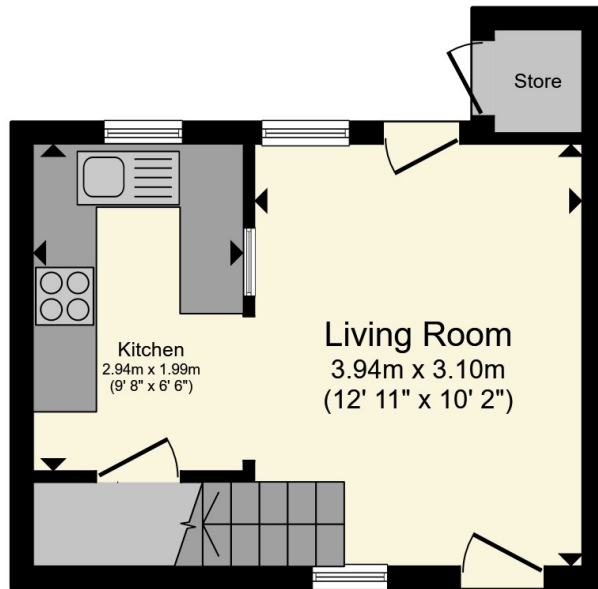

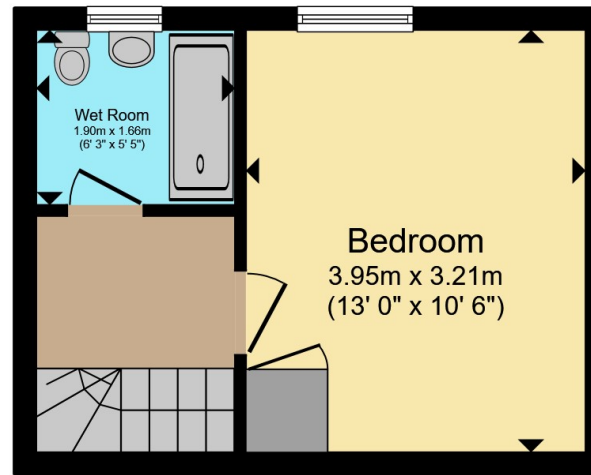








Ground Floor
