The seller has carried out some electrical upgrades in early 2026 and some damp treatment works with a 20 year guarantee.

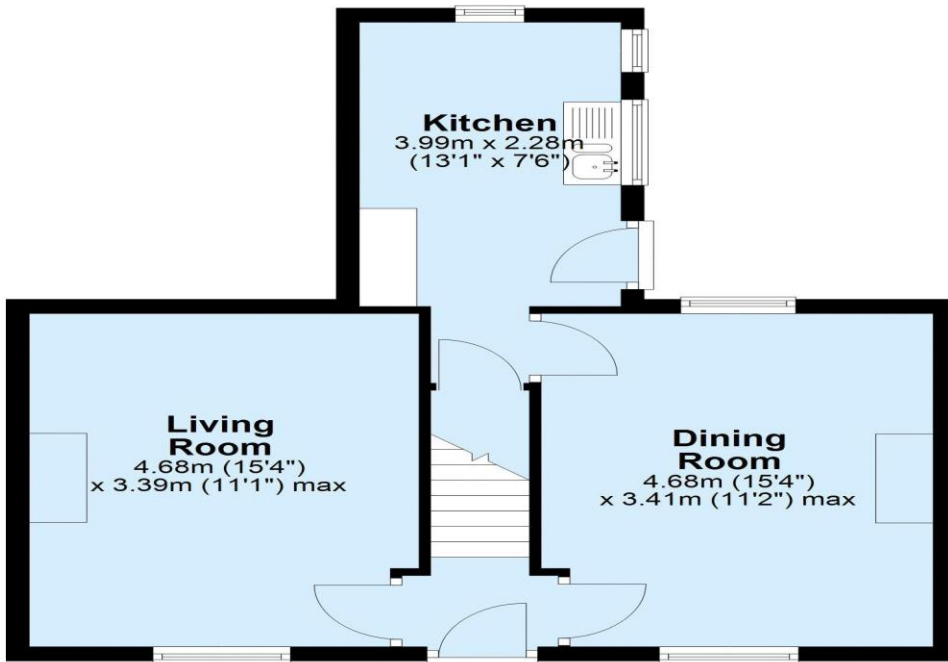

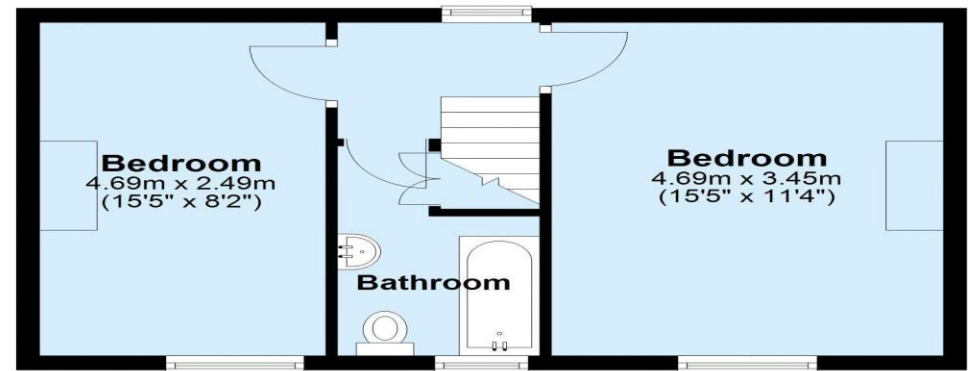
