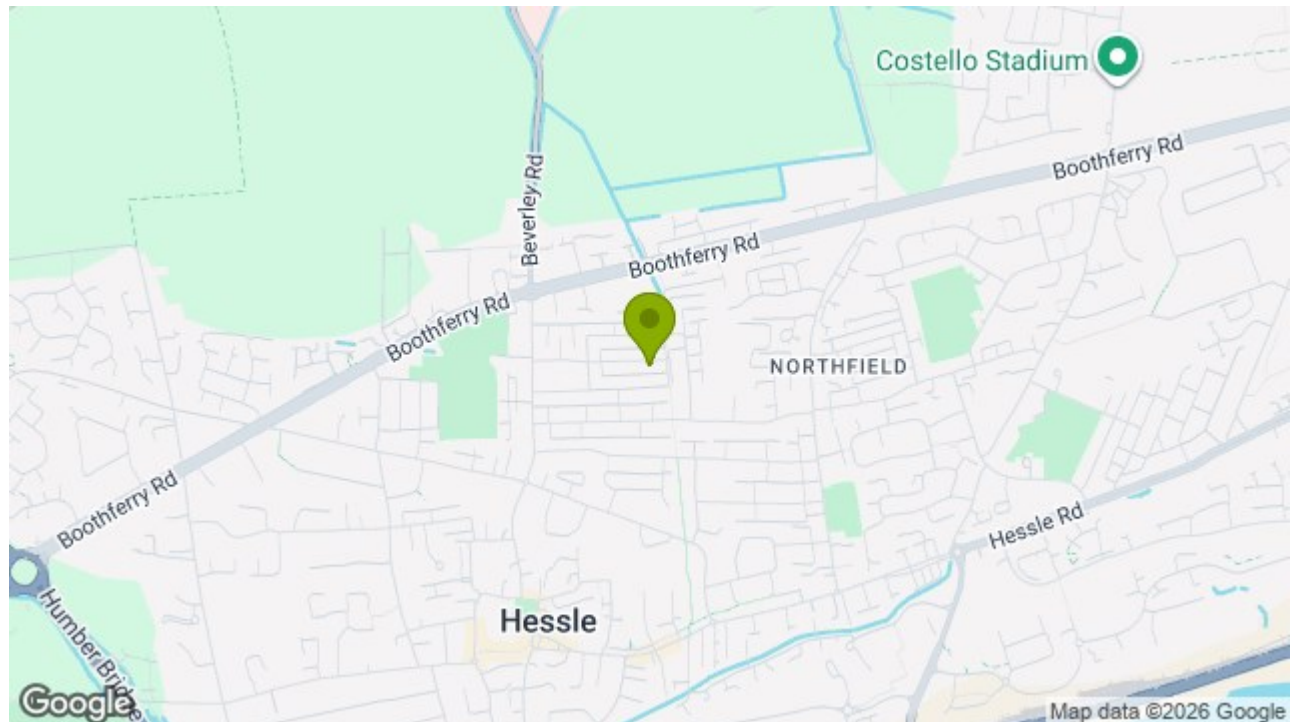
# Bedford Road, Hessle, HU13 9DQ

## HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. 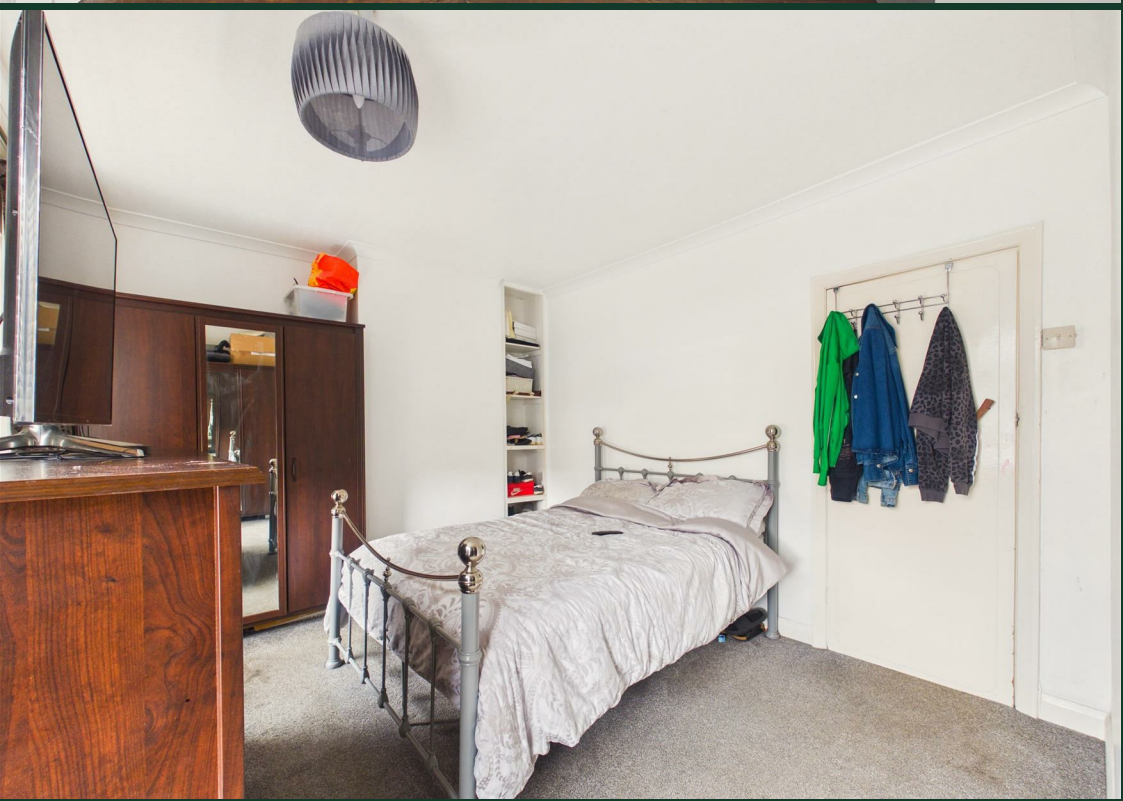
